AN ACT TO PROVIDE THAT EACH MEMBER OF THE DARLINGTON COUNTY TRANSPORTATION COMMITTEE SHALL BE ALLOWED AND PAID FROM DARLINGTON COUNTY "C" FUND REVENUES SEVENTY-FIVE DOLLARS FOR EACH MEETING AT WHICH HE IS IN ATTENDANCE, TO PROVIDE THAT THE COMMITTEE SHALL RECEIVE THE PAYMENT AUTHORIZED IN THIS ACT UPON ISSUANCE OF APPROVED VOUCHERS BY THE COMMITTEE'S CHAIRMAN, EXCEPT THAT THE CHAIRMAN MAY NOT APPROVE VOUCHERS IN ANY SINGLE FISCAL YEAR WHICH VOUCHERS AUTHORIZE PAYMENT FOR MORE THAN FIFTEEN MEETINGS PER FISCAL YEAR FOR EACH MEMBER OF THE COMMITTEE, AND TO PROVIDE THAT THE CHAIRMAN OF THE DARLINGTON COUNTY LEGISLATIVE DELEGATION SHALL BE AN EX OFFICIO NONVOTING MEMBER OF THE DARLINGTON COUNTY TRANSPORTATION COMMITTEE.

Be it enacted by the General Assembly of the State of South Carolina:

Meeting attendance pay

SECTION 1. Notwithstanding any other provision of law, each member of the Darlington County Transportation Committee, in performance of his duties, shall be allowed and paid from Darlington County "C" fund revenues the sum of seventy-five dollars for each meeting at which he is in attendance.

Payment authorized upon issuance of vouchers

SECTION 2. The Darlington County Transportation Committee shall receive the payment authorized in this act upon issuance of approved vouchers by its chairman; except that the chairman may not approve vouchers in any single fiscal year which vouchers authorize payment

for more than fifteen meetings per fiscal year for each member of the committee.

Delegation chairman to serve as ex officio member of Transportation Committee

SECTION 3. The Chairman of the Darlington County Legislative Delegation shall be an ex officio nonvoting member of the Darlington County Transportation Committee.

Time effective

SECTION 4. This act takes effect upon approval by the Governor.
