21 includes a criminal history record search, a search to determine whether a person is
22 prohibited from possessing a firearm under s. 51.20 (13) (cv), a search to determine
23 whether the person is subject to an injunction under s. 813.12 or 813.122, or a tribal
24 injunction, as defined in s. 813.12 (1) (e), issued by a court established by any
25 federally recognized Wisconsin Indian tribe or band, except the Menominee Indian

1 in the duplicate completed notification form indicates that the transferee is

6 **175.48 Law enforcement officer identification cards. (1)** In this section,

8 **(2)** If a Wisconsin law enforcement agency issues photographic identification
9 cards to its officers, it may not require an officer to relinquish his or her card upon
10 retirement unless one of the following applies:

11 (a) The officer may not lawfully possess a firearm under federal law.

12 (b) The officer did not retire in good standing from service as a law enforcement
13 officer with the agency or retired as a result of mental instability.

14 (c) The officer was regularly employed as a law enforcement officer for an
15 aggregate of less than 15 years. This paragraph does not apply if the officer, after
16 completing any applicable probationary period of service with the agency, retired
17 from service with the agency due to a service-connected disability, as determined by
18 the agency.

19 (d) The officer does not have a nonforfeitable right to benefits under the
20 agency’s retirement plan.

21 **(3)** Unless sub. (2) (a), (b), (c), or (d) applies, if a Wisconsin law enforcement
22 agency does not issue photographic identification cards to its officers, it shall issue
23 such a card to an officer formerly employed by that agency upon the former officer’s
24 request and at his or her expense.

25 **SECTION 36.** 175.49 of the statutes is created to read:

1 **175.49 Retired law enforcement officers seeking to carry concealed**
2 **weapons. (1) DEFINITIONS.** In this section:

3 (a) “Department” means the department of justice.

4 (b) “Former employer” means a law enforcement agency that employed a
5 retired law enforcement officer immediately before his or her retirement.

6 (c) “Law enforcement officer” means a person who is employed by a public
7 agency in the United States for the purpose of engaging in, or supervising others
8 engaging in, the prevention, detection, investigation, or prosecution of, or the
9 incarceration of any person for, any violation of law and who has statutory powers
10 of arrest.

11 **(2) ISSUANCE OF CERTIFICATION.** Subject to sub. (3), the department shall issue
12 and provide a retired law enforcement officer, upon request and at his or her own
13 expense, an identification card that contains the information specified in sub. (4) (b)
14 and that certifies all of the following:

15 (a) That the department has found that the retired officer has met the
16 standards established by this state for training and qualification for active duty law
17 enforcement officers to carry firearms.

18 (b) The date on which the department made the finding under par. (a).

19 (c) That, as a result of the finding under par. (a), the retired officer is qualified
20 to carry any concealed firearm other than a machine gun or a firearm bearing a
21 silencer.

22 **(3) PREREQUISITES FOR DEPARTMENT ACTION.** (a) Subsection (2) does not apply
23 with respect to a person requesting an identification card unless all of the following
24 apply:

1 1. The person retired in good standing from service as a law enforcement officer
2 for reasons other than mental instability.

3 2. At least one of the following applies:

4 a. Before retiring, the person was regularly employed as a law enforcement
5 officer for an aggregate of 15 years or more.

6 b. The person completed any applicable probationary period of service with his
7 or her former employer and retired from service due to a service-connected disability,
8 as determined his or her former employer.

9 3. The person has a nonforfeitable right to benefits under his or her former
10 employer's retirement plan.

11 4. The department determines that its records do not indicate that the person
12 is prohibited from possessing a firearm under federal law or is a person specified in
13 s. 941.29 (1) (a), (b), (bm), (c), (d), (e), or (g).

14 5. The person is a resident of this state.

15 (b) The department may require a person to sign appropriate consents for
16 release of information to enable it to confirm that he or she meets all of the
17 prerequisites under this subsection for the department to act under sub. (2).

18 (c) In addition to other fees authorized under sub. (2), the department may
19 require a person to pay a fee, not to exceed the department's costs, for verifying his
20 or her employment history or retirement plan status under par. (a) 1. to 3. or making
21 a determination under par. (a) 4.

22 **(4) CONTENTS OF IDENTIFICATION CARD.** (a) Subject to pars. (b), (c), and (d), the
23 department shall design a single document for identification cards issued under this
24 section. The department shall complete the design of the identification card

document no later than the first day of the 2nd month beginning after the effective date of this paragraph [revisor inserts date].

(b) In addition to the information certified under sub. (2), an identification card issued under this section shall contain all of the following on one side:

1. The full name, date of birth, and residence address of the retired officer.

2. A physical description of the retired officer, including sex, height, weight, and hair and eye color.

3. The name of this state.

(c) An identification card may not contain the retired officer's social security number.

(d) An identification card issued under this section shall be, to the maximum extent possible, tamper proof. The contents of the identification card shall be included in the document in substantially the same way that the contents of an operator's license document issued under s. 343.17 are included in that document.

SECTION 37. 175.50 of the statutes is created to read:

175.50 License to carry a concealed weapon. (1) DEFINITIONS. In this section:

(ab) "Alcohol beverages" has the meaning given in s. 125.02 (1).

(abm) "Alcohol concentration" has the meaning given in s. 340.01 (1v).

(ac) "Background check" means a search of department and court records conducted under sub. (9g) to determine a person's eligibility for a license to carry a concealed weapon.

(ag) Except in subs. (2g) (b) and (12g) (a) 2., "carry" means to go armed with.

(ah) "Controlled substance" means a controlled substance, as defined in s. 961.01 (4), or a controlled substance analog, as defined in s. 961.01 (4m).

1 (aj) “Department” means the department of justice.

2 (am) “Drunk driving offense” means any of the following:

3 1. A violation of s. 346.63 or a local ordinance in conformity with that section.

4 2. A violation of a law of a federally recognized American Indian tribe or band
5 in this state in conformity with s. 346.63.

6 3. A violation of the law of another jurisdiction, as defined in s. 340.01 (41m),
7 that prohibits use of a motor vehicle while intoxicated, while under the influence of
8 a controlled substance, a controlled substance analog, or a combination thereof, with
9 an excess or specified range of alcohol concentration, or while under the influence of
10 any drug to a degree that renders the person incapable of safely driving, as those or
11 substantially similar terms are used in that jurisdiction’s laws.

12 (bm) “Handgun” means any weapon designed or redesigned, or made or
13 remade, and intended to be fired while held in one hand and to use the energy of an
14 explosive to expel a projectile through a smooth or rifled bore. “Handgun” does not
15 include a machine gun, as defined in s. 941.27 (1), a short-barreled rifle, as defined
16 in s. 941.28 (1) (b), or a short-barreled shotgun, as defined in s. 941.28 (1) (c).

17 (bq) “Intoxicant” means any alcohol beverage, controlled substance, or other
18 drug, or any combination thereof.

19 (bv) “Law enforcement agency” does not include the department.

20 (c) “Law enforcement officer” has the meaning given in s. 165.85 (2) (c).

21 (d) “Licensee” means an individual holding a valid license to carry a concealed
22 weapon issued under this section.

23 (e) “Misdemeanor crime of violence” means any of the following:

24 1. A misdemeanor violation of chs. 940, 941, or 948 or of s. 947.013 or a violation
25 of s. 947.01 or of sub. (2k) (e) or (16) (cm) 1.

1 2. A crime under federal law or the law of another state that is comparable to
2 a crime described in subd. 1.

3 (eg) “Misdemeanor delinquency adjudication” means a finding that a juvenile
4 is delinquent for an act that would be a misdemeanor if committed by an adult.

5 (er) “Motor vehicle” has the meaning given in s. 340.01 (35).

6 (f) “Out-of-state authorization” means a valid permit document or a valid
7 license document issued by another state if all of the following apply:

8 1. The permit document or license document documents that a person is
9 authorized under the law of that state to carry a concealed weapon in that state.

10 2. The state is listed in the rule promulgated by the department under s. 165.25
11 (11).

12 (g) “Out-of-state licensee” means an individual who is 21 years of age or over,
13 who is not a Wisconsin resident, who has been issued an out-of-state authorization,
14 and who is not prohibited from possessing a firearm under s. 941.29 or from
15 possessing a firearm that has been transported in interstate or foreign commerce
16 under federal law.

17 (gm) “Photo identification card” means an operator’s license issued under ch.
18 343 or an identification card issued under s. 343.50.

19 (h) “Private property” has the meaning given in s. 943.13 (1e) (e).

20 (i) “Proprietor” means a person to whom a Class “B” or “Class B” license or
21 permit has been issued under ch. 125.

22 (ig) “Purpose of authorized analysis” means for the purpose of determining or
23 obtaining evidence of the presence, quantity, or concentration of any intoxicant in a
24 person’s blood, breath, or urine.

1 (im) “State identification card number” means the unique identifying driver
2 number assigned to a person by the department of transportation under s. 343.17 (3)
3 (a) 4. or, if the person presents, under sub. (6), an identification card issued under
4 s. 343.50, the number assigned to the person on that identification card.

5 (is) “Test facility” means a test facility or agency prepared to administer tests
6 under s. 343.305 (2).

7 (j) “Weapon” means a handgun, an electric weapon, as defined in s. 941.295 (4),
8 a knife other than a switchblade knife under s. 941.24, or a billy club.

9 **(2)** ISSUANCE OF LICENSE. The department shall issue licenses to carry a
10 concealed weapon to an individual who meets the qualifications specified in sub. (3)
11 and who completes the application process specified in sub. (7). A license to carry a
12 concealed weapon issued under this section shall meet the requirements specified in
13 sub. (2m).

14 **(2g)** CARRYING A CONCEALED WEAPON; CARRYING AND DISPLAY OF LICENSE DOCUMENT
15 OR AUTHORIZATION. (a) A licensee or an out-of-state licensee may carry a concealed
16 weapon anywhere in this state except as provided under sub. (15m) or (16) or s.
17 941.20 (1) (b) or 943.13 (1m) (c).

18 (b) A licensee shall carry his or her license document and photo identification
19 card and an out-of-state licensee shall carry his or her out-of-state authorization
20 at all times during which he or she is going armed with a concealed weapon.

21 (c) If he or she is carrying a concealed weapon, a licensee shall display his or
22 her license document and photo identification card and an out-of-state licensee shall
23 display his or her out-of-state authorization to a law enforcement officer upon the
24 request of the law enforcement officer.

1 **(2i) PRELIMINARY BREATH SCREENING TEST.** (a) *Requirement.* A person shall
2 provide a sample of his or her breath for a preliminary breath screening test if a law
3 enforcement officer has probable cause to believe that the person is violating sub.
4 (16) (cm) 1. and if, prior to an arrest, the law enforcement officer requested that the
5 person provide this sample.

6 (b) *Use of test results.* A law enforcement officer may use the results of a
7 preliminary breath screening test for the purpose of deciding whether or not to arrest
8 a person for a violation of sub. (16) (cm) 1. or for the purpose of deciding whether or
9 not to request a chemical test under sub. (2k). Following the preliminary breath
10 screening test, chemical tests may be required of the person under sub. (2k).

11 (c) *Admissibility.* The result of a preliminary breath screening test is not
12 admissible in any action or proceeding except to show probable cause for an arrest,
13 if the arrest is challenged, or to show that a chemical test was properly required of
14 a person under sub. (2k).

15 (d) *Refusal.* There is no penalty for a violation of par. (a). Neither sub. (17) (b)
16 nor the general penalty provision under s. 939.61 applies to that violation.

17 **(2j) IMPLIED CONSENT.** Any person who carries a concealed weapon in this state
18 is deemed to have given consent to provide one or more samples of his or her breath,
19 blood, or urine for the purpose of authorized analysis as required under sub. (2k).
20 Any person who carries a concealed weapon in this state is deemed to have given
21 consent to submit to one or more chemical tests of his or her breath, blood, or urine
22 for the purpose of authorized analysis as required under sub. (2k).

23 **(2k) CHEMICAL TESTS.** (a) *Requirement.* 1. ‘Samples; submission to tests.’ A
24 person shall provide one or more samples of his or her breath, blood, or urine for the
25 purpose of authorized analysis if he or she is arrested for a violation of sub. (16) (cm)

1 1. and if he or she is requested to provide the sample by a law enforcement officer.
2 A person shall submit to one or more chemical tests of his or her breath, blood, or
3 urine for the purpose of authorized analysis if he or she is arrested for a violation of
4 sub. (16) (cm) 1. and if he or she is requested to submit to the test by a law
5 enforcement officer.

6 2. 'Information.' A law enforcement officer requesting a person to provide a
7 sample or to submit to a chemical test under subd. 1. shall inform the person of all
8 of the following at the time of the request and prior to obtaining the sample or
9 administering the test:

10 a. That he or she is deemed to have consented to tests under sub. (2i).

11 b. That a refusal to provide a sample or to submit to a chemical test constitutes
12 a violation under par. (e) and is subject to the same penalties and procedures as a
13 violation of sub. (16) (cm) 1.

14 c. That in addition to the designated chemical test under par. (b) 2. he or she
15 may have an additional chemical test under par. (c) 1.

16 3. 'Unconscious person.' A person who is unconscious or otherwise not capable
17 of withdrawing consent is presumed not to have withdrawn consent under this
18 paragraph, and if a law enforcement officer has probable cause to believe that the
19 person violated sub. (16) (cm) 1., one or more chemical tests may be administered to
20 the person without a request under subd. 1. and without providing information
21 under subd. 2.

22 (b) *Chemical tests.* 1. 'Test facility.' Upon the request of a law enforcement
23 officer, a test facility shall administer a chemical test of breath, blood, or urine for
24 the purpose of authorized analysis. A test facility shall be prepared to administer
25 2 of the 3 chemical tests of breath, blood, or urine for the purpose of authorized

1 analysis. The department may enter into agreements for the cooperative use of test
2 facilities.

3 2. 'Designated chemical test.' A test facility shall designate one chemical test
4 of breath, blood, or urine which it is prepared to administer first for the purpose of
5 authorized analysis.

6 3. 'Additional chemical test.' A test facility shall specify one chemical test of
7 breath, blood, or urine, other than the test designated under subd. 2., which it is
8 prepared to administer for the purpose of authorized analysis as an additional
9 chemical test.

10 4. 'Validity; procedure.' A chemical test of blood or urine conducted for the
11 purpose of authorized analysis is valid as provided under s. 343.305 (6). The duties
12 and responsibilities of the laboratory of hygiene, department of health and family
13 services, and department of transportation under s. 343.305 (6) apply to a chemical
14 test of blood or urine conducted for the purpose of authorized analysis under this
15 subsection. Blood may be withdrawn from a person arrested for a violation of sub.
16 (16) (cm) 1. only by a physician, registered nurse, medical technologist, physician
17 assistant, or person acting under the direction of a physician and the person who
18 withdraws the blood, the employer of that person, and any hospital where blood is
19 withdrawn have immunity from civil or criminal liability as provided under s.
20 895.53.

21 5. 'Report.' A test facility which administers a chemical test of breath, blood,
22 or urine for the purpose of authorized analysis under this subsection shall prepare
23 a written report which shall include the findings of the chemical test, the
24 identification of the law enforcement officer or the person who requested a chemical
25 test, and the identification of the person who provided the sample or submitted to the

1 chemical test. The test facility shall transmit a copy of the report to the law
2 enforcement officer and the person who provided the sample or submitted to the
3 chemical test.

4 (c) *Additional and optional chemical tests.* 1. 'Additional chemical test.' If a
5 person is arrested for a violation of sub. (16) (cm) 1. and if the person is requested to
6 provide a sample or to submit to a test under par. (a) 1., the person may request the
7 test facility to administer the additional chemical test specified under par. (b) 3. or,
8 at his or her own expense, reasonable opportunity to have any qualified person
9 administer a chemical test of his or her breath, blood, or urine for the purpose of
10 authorized analysis.

11 2. 'Optional test.' If a person is arrested for a violation of sub. (16) (cm) 1. and
12 if the person is not requested to provide a sample or to submit to a test under par. (a)
13 1., the person may request the test facility to administer a chemical test of his or her
14 breath or, at his or her own expense, reasonable opportunity to have any qualified
15 person administer a chemical test of his or her breath, blood, or urine for the purpose
16 of authorized analysis. If a test facility is unable to perform a chemical test of breath,
17 the person may request the test facility to administer the designated chemical test
18 under par. (b) 2. or the additional chemical test under par. (b) 3.

19 3. 'Compliance with request.' A test facility shall comply with a request under
20 this paragraph to administer any chemical test that it is able to perform.

21 4. 'Inability to obtain chemical test.' The failure or inability of a person to
22 obtain a chemical test at his or her own expense does not preclude the admission of
23 evidence of the results of a chemical test required and administered under pars. (a)
24 and (b).

1 (d) *Admissibility; effect of test results; other evidence.* The results of a chemical
2 test required or administered under par. (a), (b), or (c) are admissible in any civil or
3 criminal action or proceeding arising out of the acts committed by a person alleged
4 to have violated sub. (16) (cm) 1. on the issue of whether the person had alcohol
5 concentrations at or above specified levels or was under the influence of an
6 intoxicant. Results of these chemical tests shall be given the effect required under
7 s. 885.235. This subsection does not limit the right of a law enforcement officer to
8 obtain evidence by any other lawful means.

9 (e) *Refusal.* No person may refuse a lawful request to provide one or more
10 samples of his or her breath, blood, or urine or to submit to one or more chemical tests
11 under par. (a). A person shall not be deemed to refuse to provide a sample or to submit
12 to a chemical test if it is shown by a preponderance of the evidence that the refusal
13 was due to a physical inability to provide the sample or to submit to the test due to
14 a physical disability or disease unrelated to the use of an intoxicant. Issues in any
15 action concerning a violation of par. (a) or this paragraph are limited to:

16 1. Whether the law enforcement officer had probable cause to believe the
17 person was violating or had violated sub. (16) (cm) 1.

18 2. Whether the person was lawfully placed under arrest for violating sub. (16)
19 (cm) 1.

20 3. Whether the law enforcement officer requested the person to provide a
21 sample or to submit to a chemical test and provided the information required under
22 par. (a) 2. or whether the request and information were unnecessary under par. (a)
23 3.

24 4. Whether the person refused to provide a sample or to submit to a chemical
25 test.

1 **(2m)** LICENSE DOCUMENT; CONTENT OF LICENSE. (a) Subject to pars. (b), (c), and
2 (d), the department shall design a single license document for licenses issued and
3 renewed under this section. The department shall complete the design of the license
4 document no later than the first day of the 2nd month beginning after the effective
5 date of this paragraph [revisor inserts date].

6 (b) A license document for a license issued under this section shall contain all
7 of the following on one side:

- 8 1. The full name, date of birth, and residence address of the licensee.
- 9 2. A physical description of the licensee, including sex, height, weight, and hair
10 and eye color.
- 11 3. The date on which the license was issued.
- 12 4. The date on which the license expires.
- 13 5. The name of this state.
- 14 6. A unique identification number for each licensee.

15 (c) The license document may not contain the licensee's social security number.

16 (d) A license document issued under this section shall be, to the maximum
17 extent possible, tamper proof. The contents of the license document shall be included
18 in the document in substantially the same way that the contents of an operator's
19 license document issued under s. 343.17 are included in that document.

20 **(3)** QUALIFICATIONS FOR OBTAINING A LICENSE. An individual is eligible for a
21 license under this section if all of the following apply:

- 22 (a) The individual is at least 21 years of age.
- 23 (b) The individual does not have a severe physical disability that prevents him
24 or her from safely handling a weapon and that, if the individual were handling a
25 weapon, would cause the individual to pose a significant public safety risk. The

1 department may determine that a person is ineligible for a license under this
2 paragraph only if the form that the person has submitted under (7) (d) does not
3 indicate that the person is eligible. The department may override an indication on
4 a form submitted under sub. (7) (d) that a person is not eligible for a license under
5 this paragraph. This paragraph does not apply to a person certified under sub. (3m)
6 (b) as an instructor of a firearm training or firearm safety course or class.

7 (c) The individual is not prohibited under federal law from possessing a firearm
8 that has been transported in interstate or foreign commerce.

9 (d) The individual is not prohibited from possessing a firearm under s. 941.29.

10 (e) During the preceding 3 years, the individual has not been committed under
11 s. 51.20 for being drug dependent.

12 (f) During the preceding 3 years, the individual has not been convicted for any
13 violation, or for the solicitation, conspiracy, or attempt to commit any violation, of ch.
14 961 or of a federal law or a law of another state that is comparable to any provision
15 of ch. 961.

16 (g) The individual does not chronically and habitually use alcohol beverages or
17 other substances to the extent that his or her normal faculties are impaired. A person
18 is presumed chronically and habitually to use alcohol beverages or other substances
19 to the extent that his or her normal faculties are impaired if, within the preceding
20 3 years, any of the following applies:

21 1. The individual has been committed for involuntary treatment under s. 51.45
22 (13).

23 2. The individual has been convicted of a violation of s. 941.20 (1) (b).

24 3. In 2 or more cases arising out of separate incidents, a court has found the
25 individual to have committed a drunk driving offense.

1 (h) 1. The individual has done one of the following:

2 a. Successfully completed a firearm training or firearm safety course or class
3 that meets the requirements of sub. (3m) (a) and that is conducted by an instructor
4 certified by the state in which the course or class was conducted or by a national or
5 state organization that certifies firearms instructors.

6 b. Participated in organized shooting competitions or military, law
7 enforcement, or security training that gave the applicant experience with firearms
8 that the department determines is substantially equivalent to any course or class
9 that meets the requirements of sub. (3m) (a).

10 c. Been certified as described under sub. (3m) (b) as an instructor of a firearm
11 training or firearm safety course or class.

12 2. If subd. 1. a. or b. applies, the person providing the training or organizing
13 a shooting competition in which the person has competed shall complete the form
14 designed by the department under sub. (5) (b).

15 (i) The individual has not been found incompetent under ch. 880 or, if the
16 individual has been found incompetent under ch. 880, he or she was subsequently
17 found to be competent and at least 5 years have elapsed from the date that he or she
18 was found to be competent.

19 (im) The individual was not the subject of a protective placement under s. 55.06
20 as a minor unless at least 5 years have elapsed from the date on which his or her
21 protective placement ended.

22 (j) The individual has not been involuntarily committed for treatment under
23 s. 51.20 due to mental illness or a developmental disability or, if the individual has
24 been involuntarily committed for treatment under s. 51.20 due to mental illness or
25 a developmental disability, he or she shows, through evidence from a psychiatrist

1 licensed in this state, that he or she has not been disabled due to mental illness or
2 a developmental disability for at least 5 years.

3 (k) The individual has not been found incompetent under s. 971.14 or, if the
4 individual has been found incompetent under s. 971.14, one of the following applies:

5 1. He or she was subsequently found to be competent and at least 5 years have
6 elapsed from the date that he or she was found to be competent.

7 2. He or she was not subsequently found to be competent and he or she shows,
8 through evidence from a psychiatrist licensed in this state, that he or she has not
9 been disabled due to mental illness or a developmental disability for at least 5 years.

10 (L) The individual has not been found not guilty by reason of mental disease
11 or defect under s. 971.17 or, if the individual has been found not guilty by reason of
12 mental disease or defect under s. 971.17, he or she presents evidence from a
13 psychiatrist licensed in this state that he or she has not been disabled due to mental
14 illness or a developmental disability for at least 5 years.

15 (m) Within the preceding 3 years, the individual was not convicted of a
16 misdemeanor crime of violence or was not serving a sentence, on probation, or subject
17 to a dispositional order under ch. 938 for committing a misdemeanor crime of
18 violence.

19 (mm) The individual has not been convicted of a misdemeanor violation of s.
20 940.32, 1999 stats., or a misdemeanor violation of a federal law or a law of another
21 state that is comparable to s. 940.32.

22 (mr) The individual has not been prohibited from obtaining a license under sub.
23 (10m) based on the individual having committed a misdemeanor crime of violence.

1 (n) The individual has not been charged with a felony or a misdemeanor crime
2 of violence for which the prosecution was suspended under a deferred prosecution
3 agreement unless 3 years have elapsed since the date of the agreement.

4 (o) The individual is not the subject of any pending civil or criminal case, the
5 disposition of which could disqualify him or her from having a license under this
6 subsection.

7 (p) The individual has not previously submitted an application for a license
8 under this section and had the application denied, unless each reason for the denial
9 is no longer applicable because of changed circumstances or, if the denial was based
10 on a restriction under this subsection that applies for a specified period of time,
11 because that time period has run.

12 (q) The individual has not had a license that was issued under this section
13 revoked, unless each reason for the revocation is no longer applicable because of
14 changed circumstances or, if the revocation was based on a restriction under this
15 subsection that applies for a specified period of time, because that time period has
16 run.

17 (r) Within the preceding 3 years, the individual was not convicted under sub.
18 (17) (c), (d), or (e) and was not serving a sentence, on probation, or subject to a
19 dispositional order under ch. 938 for committing an offense under sub. (17) (c), (d),
20 or (e).

21 (s) The individual is a Wisconsin resident.

22 **(3m)** COURSE OR CLASS REQUIREMENTS. (a) A firearm training or firearm safety
23 course or class under sub. (3) (h) 1. a. shall consist of all of the following:

24 1. Instruction on how to handle, load, unload, and store handguns.

1 2. Instruction on the privilege of self–defense and the defense of others under
2 s. 939.48.

3 3. Instruction on how to avoid injuring 3rd parties when defending himself,
4 herself, or others in a manner that is privileged under s. 939.48.

5 4. Instruction on basic self–defense principles.

6 5. Instruction on how to carry a concealed handgun safely.

7 6. Instruction on firing a handgun.

8 7. Practice firing a handgun.

9 (am) The department may not specify the number of hours of instruction, either
10 in the aggregate or with respect to any of the individual topics specified in par. (a)
11 1. to 7., that a course or class must provide.

12 (b) The department shall certify instructors who are qualified to teach a course
13 or class described in par. (a) and maintain a list of instructors that it certifies. To be
14 certified by the department as an instructor, a person must meet all of the following
15 criteria:

16 1. Be qualified under sub. (3) to carry a concealed weapon.

17 2. Be able to demonstrate the ability and knowledge required for instructing
18 students under par. (a) 1. to 7.

19 **(5) APPLICATION, RENEWAL, AND TRAINING FORMS.** (a) The department shall design
20 an application form for use by individuals who apply for a license under this section
21 and a renewal form for use by individuals applying for renewal of a license under sub.
22 (15). The department shall complete the design of the application form no later than
23 the first day of the 2nd month beginning after the effective date of this subsection
24 [revisor inserts date], and shall complete the design of the renewal form no later than
25 the first day of the 36th month beginning after the effective date of this subsection

1 [revisor inserts date]. The forms shall require the applicant to provide only his
2 or her name, address, date of birth, state identification card number, race, sex,
3 height, weight, and hair and eye color and the registration number for each motor
4 vehicle registered in the applicant's name and shall include all of the following:

5 1. A statement that the applicant is eligible for a license if the requirements
6 specified in sub. (3) are met.

7 2. A statement explaining the privilege of self-defense and defense of others
8 under s. 939.48, with a place for the applicant to sign his or her name to indicate that
9 he or she has read and understands the statement.

10 3. A statement, with a place for the applicant to sign his or her name, to indicate
11 that the applicant has read and understands the requirements of this section.

12 4. A statement that the application must include the notarized statement
13 described under sub. (7) (b) and that an applicant may be prosecuted if he or she gives
14 a false answer to any question on the application or submits a falsified document
15 with the application.

16 5. A statement of the penalties for giving a false answer to any question on the
17 application or submitting a falsified document with the application.

18 (b) The department shall design a form for use by individuals listed in sub. (3)
19 (h) 2. to verify a person's eligibility for a license under sub. (3) (b) and (h) 1. The form
20 shall provide for verification of a person's eligibility under sub. (3) (b) by providing
21 a space for the individual completing the form to check a box indicating whether the
22 person is eligible for a license under sub. (3) (b).

23 (c) The department shall make the forms described in this subsection available
24 on the Internet or by mail upon request.

1 **(6) REVIEW BY NOTARY.** Before a person submits an application under sub. (7),
2 the person shall display a valid license document or identification card that he or she
3 has been issued under s. 343.17 or 343.50 to the notary who is to notarize the
4 statement required under sub. (7) (b). Before notarizing that statement, the notary
5 shall verify the person's identity using that license document or identification card
6 and verify that the name and state identification card number listed on the license
7 document or identification card are the same as the name and state identification
8 card number listed on the application.

9 **(7) SUBMISSION OF APPLICATION.** An individual may apply for a license under this
10 section with the department by submitting to the department all of the following:

11 (a) A completed application in the form prescribed under sub. (5) (a).

12 (b) A notarized statement that states that the information that he or she is
13 providing in the application submitted under par. (a) and any document submitted
14 with the application is true and complete to the best of his or her knowledge.

15 (bd) A license fee of \$52.

16 (bh) A fee for a background check of \$8.

17 (bp) A shooting range improvement fee of \$15 written as a separate check,
18 made out to the applicant's county of residence, that the department shall forward
19 to that county on at least a quarterly basis.

20 (d) A training certificate, in the form created by the department under sub. (5)
21 (b), that is completed by the person specified in sub. (3) (h) 2. and that shows that the
22 person is eligible for a license under sub. (3) (b) and (h) 1. This paragraph does not
23 apply to a person certified under sub. (3m) (b) as an instructor of a firearm training
24 or firearm safety course or class.

1 **(9) PROCESSING OF APPLICATION.** (a) Upon receiving an application submitted
2 under sub. (7), the department shall conduct a background check, as provided under
3 sub. (9g).

4 (b) Subject to par. (c), within 21 days after receiving an application under sub.
5 (7), the department shall do one of the following:

6 1. Issue the license and promptly send the licensee his or her license document
7 by 1st class mail.

8 2. Deny the application, but only if the applicant fails to qualify under the
9 criteria specified in sub. (3). If the department denies the application, the
10 department shall inform the applicant in writing, stating the reason and factual
11 basis for the denial to the extent permitted under federal law.

12 (c) The time period specified in par. (b) (intro.) is tolled during the pendency of
13 any action brought under sub. (10m).

14 **(9g) BACKGROUND CHECKS.** (b) The department shall conduct a background
15 check regarding an applicant for a license using the following procedure:

16 1. The department shall create a confirmation number associated with the
17 applicant.

18 2. The department shall use the transaction information for management of
19 enforcement system and the national crime information center system.

20 3. As soon as practicable, the department shall do the following:

21 a. If the background check indicates that the applicant does not qualify for a
22 license under sub. (3) (c), (d), (e), (f), (g), (i), (im), (j), (k), (L), (m), (mm), (n), (o), or (r),
23 create a unique nonapproval number for the applicant.

1 b. If the completed background check does not indicate that the applicant is
2 disqualified for a license under sub. (3) (c), (d), (e), (f), (g), (i), (im), (j), (k), (L), (m),
3 (mm), (n), (o), or (r), create a unique approval number for the applicant.

4 c. If the background check indicates that the applicant was the subject of a
5 relevant criminal charge for which there is no recorded disposition or if, in the case
6 of a misdemeanor delinquency adjudication, the background check does not indicate
7 how long the resultant dispositional order was in effect, make all reasonable efforts
8 to obtain the missing information.

9 (c) The department shall conduct the background check under par. (b)
10 immediately if the background check is for an applicant for an emergency license
11 under sub. (9r).

12 (d) The department shall maintain the record of all completed application
13 forms and a record of all approval or nonapproval numbers regarding background
14 checks under this subsection.

15 (e) 1. The department shall check each application form. If the department
16 provided a unique approval number regarding the request, the department shall,
17 except as provided in subd. 2., destroy all records regarding that background check
18 within 30 days after receiving the form.

19 2. The department may maintain records necessary to administer this
20 subsection and, for a period of not more than 15 months after the department issues
21 a unique approval number, a log of dates of background checks under this subsection
22 together with unique approval and nonapproval numbers corresponding to those
23 dates.

1 (f) The department shall promulgate rules authorizing it to obtain records
2 necessary to determine an applicant's eligibility under sub. (3) (e), (g) 1., (i), (im), and
3 (j) for a license issued under this section.

4 **(9r) EMERGENCY LICENSE.** (a) Unless the department knows that the person is
5 not qualified for a license under sub. (3) (a) to (g) or (i) to (s), the department shall
6 issue a license under this section to an individual who does not satisfy the
7 requirements under sub. (3) (h) 1. if the department determines that immediate
8 licensure is warranted to protect the individual from death or great bodily harm, as
9 defined in s. 939.22 (14). If the individual has obtained a temporary restraining
10 order or injunction under s. 813.12 or 813.125 or a foreign protection order that meets
11 the requirements of s. 806.247 (2) and that has the same effect as an order issued
12 under s. 813.12 or 813.125, the department shall presume that immediate licensure
13 is warranted to protect the individual from death or great bodily harm. If the
14 department issues a license under this paragraph it shall conduct an immediate
15 background check under sub. (9g).

16 (b) 1. Except as provided in subd. 2. and par. (d), a license issued under par. (a)
17 is valid for 120 days from the date on which it is issued and may not be renewed.

18 2. If the department learns that an individual to whom the department has
19 issued a license under par. (a) does not qualify for a license under sub. (3) (c), (d), (e),
20 (f), (g), (i), (im), (j), (k), (L), (m), (mm), (n), (o), or (r), the department shall revoke the
21 license.

22 (c) The department may waive the fees that would otherwise be required under
23 sub. (7) (bd), (bh), and (bp) for an individual who is applying for a license under par.
24 (a) if requiring the individual to pay the fees would create a hardship for the
25 individual. The department shall promulgate rules specifying the procedures and

1 definitions to apply when determining whether an individual is eligible for a waiver
2 of the fees for an emergency license under this section as provided under this
3 paragraph.

4 (d) A person who has been issued a license under par. (a) may obtain a license
5 under sub. (2) if he or she meets the qualifications specified under sub. (3) and
6 completes the application process specified in sub. (7). A license issued to a person
7 under par. (a) is void if the person is issued a license under sub. (2).

8 **(10)** EXEMPTION FROM BACKGROUND CHECK. Notwithstanding subs. (9) (a) and
9 (15) (c), the department shall issue or renew a license under this section to any of the
10 following individuals without requesting a background check:

11 (a) A law enforcement officer.

12 (b) A correctional officer.

13 (c) A probation, parole, and extended supervision agent.

14 (d) A person who holds a current certification from the law enforcement
15 standards board under s. 165.85 (3) (c).

16 **(10m)** DISQUALIFICATION PETITION REGARDING CERTAIN MISDEMEANANTS. (a) If the
17 department receives an application for a license under this section from a person who
18 has committed a misdemeanor crime of violence and the person is eligible for a
19 license under sub. (3) (m), the department may file a petition under this subsection
20 asking the circuit court to enter an order barring the person from receiving a license.
21 The department may only file such a petition if the petition alleges that, based on the
22 person's commission of one or more misdemeanor crimes of violence, the person
23 would pose a substantial risk to others if the person were issued a license under this
24 section.

1 (b) The department shall file any such petition in the circuit court of the
2 person's county of residence. The department may not file the petition more than 30
3 days after receiving the person's completed application, unless the person was issued
4 a license under sub. (9r). The court shall allow the person 30 days to file an answer
5 to the petition. The court may hold an evidentiary hearing on the petition.

6 (c) If the court determines, by clear and convincing evidence, that the person
7 would pose a substantial risk to others if the person were issued a license under this
8 section, the court shall enter an order prohibiting the person from obtaining a license
9 under this section.

10 (d) If the court denies the department's petition, the court shall award the
11 person costs and reasonable attorney fees.

12 (e) The court shall expedite any proceeding brought under this subsection.

13 **(11)** UPDATED INFORMATION. (a) 1. In this paragraph:

14 a. "Clerk" means the clerk of the circuit court or, if it has enacted a law or an
15 ordinance in conformity with s. 346.63, the clerk of the court for a federally
16 recognized American Indian tribe or band in this state, a city, a village, or a town.

17 b. "Court automated information systems" means the systems under s. 758.19
18 (4).

19 2. The court automated information systems, or the clerk or register in probate,
20 if the information is not contained in or cannot be transmitted by the court
21 automated information systems, shall promptly notify the department of the name
22 of any individual with respect to whom any of the following occurs and the specific
23 reason for the notification:

24 a. The individual is charged with a felony, a misdemeanor crime of violence, a
25 violation of ch. 961, the solicitation, conspiracy, or attempt to commit any violation

1 of ch. 961, a violation of s. 941.20 (1) (b), a violation of sub. (17) (c), (d), or (e), or any
2 other crime that, upon conviction, would disqualify the individual from having a
3 license under this section.

4 b. The individual is charged with a drunk driving offense.

5 c. The individual is found by a court to have committed any offense described
6 in subd. 2. a. or b.

7 d. Prosecution of a felony or a misdemeanor crime of violence for which the
8 individual is charged is suspended under a deferred prosecution agreement.

9 e. The individual is found incompetent under s. 971.14.

10 f. The individual is found not guilty of any crime by reason of mental disease
11 or mental defect under s. 971.17.

12 g. The individual is involuntarily committed for treatment under s. 51.20 or
13 51.45.

14 h. The individual is found incompetent under ch. 880.

15 i. The individual becomes subject to an injunction described in s. 941.29 (1) (f)
16 or is ordered not to possess a firearm under s. 813.125 (4m).

17 j. A court has prohibited the individual from possessing a dangerous weapon
18 under s. 969.02 (3) (c).

19 3. Upon receiving a notice under subd. 2., the department shall immediately
20 determine if the individual who is the subject of the notice is a licensee, using the list
21 maintained under sub. (12) (a).

22 (b) 1. Within 10 days after being charged under federal law or the law of
23 another state with any crime or any drunk driving offense, a licensee shall notify the
24 department of the charge.

1 2. No later than 30 days after changing his or her address, a licensee shall
2 inform the department of his or her new address. The department shall include the
3 individual's new address in the list under sub. (12) (a).

4 **(12) MAINTENANCE, USE, AND PUBLICATION OF RECORDS BY THE DEPARTMENT.** (a) The
5 department shall maintain a computerized record listing the names and the
6 information specified in sub. (2m) (b) of all individuals who have been issued a license
7 under this section. Except as provided in par. (b) 1. and subject to par. (b) 2., neither
8 the department nor any employee of the department may store, maintain, format,
9 sort, or access the information in any way other than by the names, dates of birth,
10 or sex of licensees or by the identification numbers assigned to licensees under sub.
11 (2m) (b) 6.

12 (b) 1. A law enforcement officer who is employed by the department may obtain
13 information regarding a licensee from the department of transportation under s.
14 341.175 (4).

15 2. A law enforcement officer who is employed by the department may not
16 request or be provided information maintained by the department under par. (a)
17 concerning a specific licensee except for one of the following purposes:

18 a. To confirm that a license produced by an individual at the request of a law
19 enforcement officer is valid.

20 b. To confirm that an individual holds a valid license under this section, if the
21 individual is going armed with a concealed weapon but is not carrying his or her
22 license document and claims to hold a valid license issued under this section.

23 c. To investigate whether an individual submitted an intentionally false
24 notarized statement under sub. (7) (b) or (15) (b) 2., intentionally violated sub. (11)

1 (b) 1., or intentionally made a false statement to the department in connection with
2 the individual's request for an emergency license under sub. (9r).

3 d. To investigate whether an individual complied with sub. (11) (b) 1. or (14) (b)
4 2.

5 (c) Notwithstanding s. 19.35, neither the department nor any department
6 employee may make information obtained under this section available to the public
7 except in the context of a prosecution for an offense in which the person's status as
8 a licensee is relevant, in the context of a proceeding under sub. (10m), or through a
9 report created under sub. (19).

10 **(12g)** PROVIDING LICENSEE INFORMATION TO LAW ENFORCEMENT AGENCIES. (a) The
11 department shall provide information concerning a specific licensee to a law
12 enforcement agency, but only if the law enforcement agency is requesting the
13 information for any of the following purposes:

14 1. To confirm that a license produced by an individual at the request of a law
15 enforcement officer is valid.

16 2. To confirm that an individual holds a valid license under this section, if the
17 individual is going armed with a concealed weapon but is not carrying his or her
18 license document and claims to hold a valid license issued under this section.

19 3. To investigate whether an individual submitted an intentionally false
20 notarized statement under sub. (7) (b) or (15) (b) 2., intentionally violated sub. (11)
21 (b) 1., or intentionally made a false statement to the department in connection with
22 the individual's request for an emergency license under sub. (9r).

23 (b) 1. Notwithstanding s. 19.35, neither a law enforcement agency nor any of
24 its employees may make information regarding an individual that was obtained from
25 the department under this subsection or from the department of transportation

1 under s. 341.175 available to the public except in the context of a prosecution for an
2 offense in which the person's status as a licensee is relevant.

3 2. Neither a law enforcement agency nor any of its employees may store or
4 maintain information regarding an individual that was obtained from the
5 department under this subsection or from the department of transportation under
6 s. 341.175 based on the individual's status as a licensee.

7 3. Neither a law enforcement agency nor any of its employees may sort or access
8 information regarding vehicle stops, investigations, civil or criminal offenses, or
9 other activities involving the agency based on the status as licensees of any
10 individuals involved.

11 **(12r)** PROVIDING LICENSEE INFORMATION TO THE DEPARTMENT OF TRANSPORTATION.
12 If any of the following happens with respect to a person, the department shall notify
13 the department of transportation of the person's name, date of birth, and sex, the
14 date on which the person was last issued a license under this section, and any vehicle
15 registration number provided by the person on his or her application for that license:

16 (a) The person is issued a license.

17 (b) The person's license is renewed.

18 (c) The person's license expires and is not renewed.

19 (d) The person's license is suspended or revoked.

20 (e) The person's suspended license is reinstated.

21 **(13)** LOST OR DESTROYED LICENSE. No later than 30 days after losing his or her
22 license document or after his or her license document is destroyed, a licensee shall
23 submit to the department a notarized statement that his or her license document has
24 been lost or destroyed. The department shall issue a replacement license document

1 within 14 days of receiving the notarized statement and a replacement license fee of
2 \$15.

3 **(14)** LICENSE REVOCATION AND SUSPENSION. (a) The department shall revoke a
4 license issued under this section if the licensee no longer meets all of the criteria
5 specified in sub. (3) (b) to (g), (i) to (n), and (p) to (s).

6 (am) 1. If any of the following occurs with respect to a licensee, the department
7 shall suspend the licensee's license:

8 a. The licensee is the subject of a pending civil or criminal case, the disposition
9 of which could require revocation of his or her license under par. (a).

10 b. A court has prohibited the licensee from possessing a dangerous weapon
11 under s. 969.02 (3) (c).

12 2. If the department suspends a license under subd. 1., and, upon disposition
13 of the case, the person to whom the license was issued meets all of the criteria
14 specified in sub. (3), the department shall restore the license within 14 days of
15 receiving the disposition.

16 (b) 1. If the department revokes or suspends a license under this section, the
17 revocation or suspension shall take effect immediately.

18 2. If the department suspends or revokes a license issued under this section,
19 it shall send the individual whose license has been suspended or revoked notice of
20 the suspension or revocation by certified mail within one day after the suspension
21 or revocation. Within 7 days after receiving the notice, the individual whose license
22 has been suspended or revoked shall deliver the license document personally or by
23 certified mail to the department.

24 **(14g)** DEPARTMENTAL REVIEW. The department shall promulgate rules providing
25 for the review of any action by the department denying an application for a license

1 under this section, suspending or revoking a license under this section, or denying
2 certification as an instructor under sub. (3m) (b).

3 **(14m)** APPEALS TO THE CIRCUIT COURT. (a) A person aggrieved by any action by
4 the department denying an application for a license under this section, suspending
5 or revoking a license under this section, or denying certification as an instructor
6 under sub. (3m) (b) may appeal directly to the circuit court of his or her county, but
7 only if the person has completed the review process established under sub. (14g).

8 (b) To begin an appeal under this subsection, the aggrieved person shall file a
9 petition for review with the clerk of the applicable circuit court within 30 days after
10 the completion of the review process established under sub. (14g). The petition shall
11 state the substance of the department's action that the person is appealing from and
12 the grounds upon which the person believes the department's action to be improper.
13 The petition may include a copy of any records or documents that are relevant to the
14 grounds upon which the person believes the department's action to be improper.

15 (c) A copy of the petition shall be served upon the department either personally
16 or by registered or certified mail within 5 days after the person files his or her petition
17 under par. (b).

18 (d) The department shall file an answer within 15 days after being served with
19 the petition under par. (c). The answer shall include a brief statement of the actions
20 taken by the department. A copy of any documents or records on which the
21 department based its action shall be included with the answer when filed.

22 (e) The court shall review the petition, the answer, and any records or
23 documents submitted with the petition or the answer. The review under this
24 paragraph shall be conducted by the court without a jury and shall be confined to the
25 petition, the answer, and any records or documents submitted with the petition or

1 the answer, except that in cases of alleged irregularities in procedure by the
2 department the court may take testimony that the court determines is appropriate.

3 (f) The court shall affirm the department's action unless the court finds any of
4 the following:

5 1. That the department failed to follow procedure prescribed under this section.

6 2. That the department erroneously interpreted a provision of law and a correct
7 interpretation compels a different action.

8 3. That the department's action depends on a finding of fact that is not
9 supported by substantial evidence in the record.

10 (g) 1. The court's decision shall provide whatever relief is appropriate
11 regardless of the original form of the petition.

12 2. If the court overturns the department's decision under sub. (3m) (b), the court
13 shall order the department to pay the aggrieved person all court costs and reasonable
14 attorney fees.

15 **(15) LICENSE EXPIRATION AND RENEWAL.** (a) Except as provided in par. (e) and
16 sub. (9r) (b) 1., a license issued under this section is valid for a period of 5 years from
17 the date on which the license is issued unless the license is suspended or revoked
18 under sub. (9g) (e) 1. or (14).

19 (b) The department shall design a notice of expiration form. At least 90 days
20 before the expiration date of a license issued under this section, the department shall
21 mail to the licensee a notice of expiration form and a form for renewing the license.
22 The department shall renew the license if, before the date the license expires, the
23 licensee does all of the following:

24 1. Submits a renewal application on the form provided by the department.

1 2. Submits a notarized statement reporting that the information provided
2 under subd. 1. is true and complete to the best of his or her knowledge and that he
3 or she is qualified under sub. (3).

4 4. Pays all of the following:

5 a. A \$27 renewal fee.

6 b. A fee for a background check of \$8.

7 c. A shooting range improvement fee of \$15 written as a separate check, made
8 out to the applicant's county of residence, that the department shall forward to that
9 county on at least a quarterly basis.

10 (c) The department shall conduct a background check of a licensee as provided
11 under sub. (9g) before renewing the licensee's license under par. (b).

12 (d) If an individual whose license has expired does not submit a renewal
13 application under par. (b) before 6 months after the expiration date, the license shall
14 permanently expire. An individual whose license has permanently expired may
15 apply for a new license under sub. (7).

16 (e) The license of a member of the U.S. armed forces, a reserve unit of the armed
17 forces, or the national guard who is deployed overseas while on active duty may not
18 expire until at least 90 days after the end of the licensee's overseas deployment
19 unless the license is suspended or revoked under sub. (9g) (e) 1. or (14).

20 **(15m)** PRIVATE EMPLOYER RESTRICTIONS. (a) Except as provided in par. (b), a
21 private employer may prohibit a licensee or an out-of-state licensee that it employs
22 from carrying a concealed weapon or a particular type of concealed weapon in the
23 course of the licensee's or out-of-state licensee's employment or during any part of
24 the licensee's or out-of-state licensee's course of employment.

(b) A private employer may not prohibit a licensee or an out-of-state licensee, as a condition of employment, from carrying a concealed weapon or a particular type of concealed weapon in the licensee's or out-of-state licensee's own motor vehicle, regardless of whether the motor vehicle is used in the course of employment.

(16) PROHIBITED ACTIVITY. (a) Neither a licensee nor an out-of-state licensee may knowingly carry a concealed weapon in any of the following places:

1. A place that has been declared a nuisance under ch. 823.

2. A police station, sheriff's office, or state patrol station. This subdivision does not prohibit a peace officer who is acting within the scope of his or her employment from carrying a concealed weapon in a police station, sheriff's office, or state patrol station.

3. A prison, jail, house of correction, or secured correctional facility.

4. A courthouse, except that a judge who is a licensee may carry a concealed weapon in a courthouse in which he or she is presiding in court and may permit in writing any other licensee or out-of-state licensee to carry a concealed weapon in a courthouse in which he or she is presiding in court.

5. A place at which a school, college, or professional athletic event is taking place, unless the event is related to firearms and the licensee or out-of-state licensee is a participant in the event.

5m. A place at which an organized youth sporting event is taking place.

6. A school administration building.

7. Any premises for which a Class "B" or "Class B" license or permit has been issued under ch. 125, unless one of the following applies:

a. The licensee or the out-of-state licensee is a person described in s. 941.237

(3) (a), (b), (c), (cm), or (d).

1 b. If the licensee or the out-of-state licensee is carrying a handgun, his or her
2 possession of the handgun is described in s. 941.237 (3) (e), (f), (g), (h), (i), or (j).

3 c. The sale of intoxicating liquors or fermented malt beverages or both on those
4 premises accounts for not more than 50 percent of the proprietor's annual gross
5 receipts from those premises.

6 8. A security checkpoint or a place beyond a security checkpoint in an airport,
7 unless the weapon is encased for shipment as baggage to be transported by aircraft.

8 9. A place in which carrying the weapon is prohibited by federal law.

9 10. A kindergarten facility or classroom.

10 11. A child care center licensed under s. 48.65. This subdivision does not apply
11 to the owner of the child care center or, if the child care center is located in a residence,
12 to a person who resides in that residence.

13 12. A building or part of a building that is used for a domestic violence victim
14 services program or by an organization that provides a safe haven for victims of
15 domestic violence.

16 13. A building or part of a building that is used for religious worship or another
17 religious purpose, except that the owner of the building or an authorized
18 representative of the owner may permit a licensee or out-of-state licensee to carry
19 a concealed weapon in the building or a part of the building.

20 14. A health-related facility, except that the director of any health-related
21 facility, or his or her authorized representative, may permit a licensee or
22 out-of-state licensee to carry a concealed weapon in the health-related facility. In
23 this subdivision "health-related facility" means a health care facility, as defined in
24 s. 150.84 (2); a clinic or office that is used by a physician licensed under ch. 448; an
25 adult family home, as defined in s. 50.01 (1); a residential care apartment complex,

1 as defined in s. 50.01 (1d); a facility, as defined in s. 50.01 (1m); or a home health
2 agency, as defined in s. 50.49 (1) (a).

3 15. A building located on the campus of a private or public university, college,
4 or technical college, except that the president of a private university or college; the
5 chancellor of an institution, as defined in s. 36.05 (9), except the chancellor of the
6 University of Wisconsin Colleges, as defined in s. 36.05 (14); the dean of a college
7 campus, as defined in s. 36.05 (6m); or the director of a technical college district may
8 permit a licensee or out-of-state licensee to carry a concealed weapon in a building
9 under his or her jurisdiction.

10 16. A building owned by a nonprofit organization, whose primary function is
11 to provide direct services to children or families, in or at which the nonprofit
12 organization provides direct services to children or families.

13 (at) Neither a licensee nor an out-of-state licensee may carry a concealed
14 weapon in a building owned or leased by the state or any political subdivision of the
15 state if the building provides electronic screening for weapons at all public entrances
16 to the building and for the locked storage of weapons on the premises while the
17 licensee or out-of-state licensee is in the building. This paragraph does not apply
18 to:

19 1. Peace officers or armed forces or military personnel who go armed in the line
20 of duty.

21 2. A person authorized to carry a weapon in the building by the chief of police
22 of the city, village, or town or the sheriff of the county in which the building is located.

23 3. A person authorized to carry a weapon in the building by the chief of the
24 capitol police, if the building is owned or leased by the state.

1 (b) Neither a licensee nor an out-of-state licensee may knowingly carry a
2 handgun in a school zone, as defined in s. 948.605 (1) (c), unless he or she is not in
3 or on the grounds of a school, as defined in s. 948.61 (1) (b), and one of the following
4 applies:

5 1. The individual is in a motor vehicle or on a snowmobile or bicycle.

6 2. The individual has exited a motor vehicle and is encasing the handgun or
7 storing it in the motor vehicle.

8 3. The individual is traveling directly to any person's private property from his
9 or her place of employment or business, from any person's private property, or from
10 a place outside of the school zone.

11 4. The individual is traveling directly to his or her place of employment or
12 business from another place of his or her employment or business, from any person's
13 private property, or from a place outside of the school zone.

14 5. The individual is traveling directly to a place outside of the school zone from
15 another place outside of the school zone, from any individual's private property, or
16 from his or her place of employment or business.

17 6. The individual's possession of the handgun is described in s. 948.605 (2) (b).

18 (c) Neither a licensee nor an out-of-state licensee may knowingly carry a
19 weapon other than a handgun on school premises, as defined in s. 948.61 (1) (c),
20 unless he or she is a person described in or a person whose conduct is described in
21 s. 948.61 (3).

22 (cm) 1. A person may not carry a concealed weapon if any of the following
23 applies:

24 a. The person's alcohol concentration exceeds 0.08.

1 b. The person is under the influence of an intoxicant to a degree which
2 materially impairs his or her ability to handle the weapon.

3 2. A person may be charged with and a prosecutor may proceed upon a
4 complaint based upon a violation of subd. 1. a. or b. or both for acts arising out of the
5 same incident or occurrence. If the person is charged with violating both subd. 1. a.
6 and b., the offenses shall be joined. Subdivision 1. a. and b. each requires proof of a
7 fact for conviction which the other does not require.

8 (d) Paragraphs (a), (at), (b), and (c) do not apply to a peace officer, as defined
9 in s. 939.22 (22).

10 **(17) PENALTIES.** (a) Any person who violates sub. (2g) (b) or (c) may be required
11 to forfeit not more than \$25.

12 (ag) Any person who violates sub. (12) or (12g) may be fined not more than \$500
13 or sentenced to a term of imprisonment of not more than 30 days or both.

14 (ar) Any law enforcement officer who uses excessive force based solely on an
15 individual's status as a licensee may be fined not more than \$500 or sentenced to a
16 term of imprisonment of not more than 30 days or both.

17 (b) Any person who violates sub. (16) (a), (at), (b), or (c) may be fined not more
18 than \$1,000 or imprisoned for not more than 90 days or both.

19 (bm) Any person who violates sub. (2k) (e) or (16) (cm) 1. may be fined not more
20 than \$10,000 or imprisoned for not more than 9 months or both.

21 (c) Any person who submits an intentionally false notarized statement under
22 sub. (7) (b) or (15) (b) 2. or who intentionally makes a false statement to the
23 department in requesting or in connection with the issuance of an emergency license
24 under sub. (9r) shall be fined not less than \$500 nor more than \$10,000 and may be
25 imprisoned for not more than 9 months.

1 (d) Any person who intentionally violates sub. (11) (b) 1. shall be fined not less
2 than \$500 nor more than \$10,000 and may be imprisoned for not more than 9 months.

3 (e) Any person required under sub. (14) (b) 2. to relinquish or deliver a license
4 document to the department who intentionally violates the requirements of that
5 subdivision shall be fined not less than \$500 nor more than \$10,000 and may be
6 imprisoned for not more than 9 months.

7 **(19) STATISTICAL REPORT.** By March 1 of each year, the department shall submit
8 a statistical report to the legislature under s. 13.172 (2) and to the governor that
9 indicates the number of licenses applied for, issued, denied, suspended, and revoked
10 under this section during the previous calendar year. For the licenses denied, the
11 report shall indicate the reasons for the denials and the part of the application
12 process in which the reasons for denial were discovered. For the licenses suspended
13 or revoked, the report shall indicate the reasons for the suspensions and revocations.

14 **(20m) GRANTS FOR SHOOTING RANGES.** (a) Using the fees collected under subs.

17 defined in s. 175.50 (1) (g), if the firearm is a handgun, as defined in s. 175.50 (1) (bm).

18 **SECTION 80.** 948.61 (3m) of the statutes is created to read:

19 948.61 **(3m)** This section does not apply to the possession of a weapon, as
20 defined in s. 175.50 (1) (j), other than a handgun, as defined in s. 175.50 (1) (bm), by
21 a licensee, as defined in s. 175.50 (1) (d), or an out-of-state licensee, as defined in s.
22 175.50 (1) (g).

23 **SECTION 81. Nonstatutory provisions.**

24 (1) Using the procedure under section 227.24 of the statutes, the department
25 of justice shall promulgate rules required under section 175.35 (2g) (c) 3. of the

1 statutes and under sections 165.25 (11) (a) and 175.50 (9g) (f) of the statutes, as
2 created by this act, for the period before the effective date of the permanent rules
3 promulgated under those sections, but not to exceed the period authorized under
4 section 227.24 (1) (c) and (2) of the statutes. Notwithstanding section 227.24 (1) (a),
5 (2) (b), and (3) of the statutes, the department is not required to provide evidence that
6 promulgating a rule under this subsection as an emergency rule is necessary for the
7 preservation of public peace, health, safety, or welfare and is not required to provide
8 a finding of an emergency for a rule promulgated under this subsection.

9 **SECTION 82. Effective dates.** This act takes effect on the first day of the 4th
10 month beginning after publication, except as follows:

11 (1) The treatment of sections 165.25 (11) (a), 175.49 (4), and 175.50 (2m), (3m)
12 (b), and (5) of the statutes and SECTION 81 (1) of this act take effect on the day after
13 publication.
