ENGROSSED

A BILL
TO BE ENTITLED
AN ACT

To make appropriations for the ordinary expenses of the executive, legislative and judicial agencies of the State, for other functions of government, for debt service, and for capital outlay for the fiscal year ending September 30, 2013.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The monies in Section 2 are appropriated from the named funds for the 2012-2013 fiscal year to the state agencies indicated, as the amounts to be used to pay the expenditures of the named agencies, and are in lieu of all monies appropriated for these purposes in other sections of the Alabama Statutes.

For the purpose of this act, the amounts herein for expenditures are listed by programmatic area and the totals for all programs are shown by the source of funds. It is intended that only the herein named funds be appropriated in the amounts specified to the named agencies and that the following definitions shall be applicable.

"Appropriation Total" shall mean the aggregate total of all fund sources.

1 "Program" shall mean specific governmental services
2 required to achieve a specific objective. A program shall be
3 directed to meeting the need of an identified clientele, or
4 group of recipients or beneficiaries, and shall be expended
5 only for such purposes.

6 "Capital Outlay" shall mean expenditures which
7 result in the acquisition and/or addition to items, such as
8 land or buildings, which have an appreciable and calculable
9 period of usefulness in excess of one year, and shall be
10 expended only for such purposes.

11 "Debt Service" shall mean an expenditure for the
12 payment of interest and principal on bonded debt obligations
13 of the State, and shall be expended only for such purposes.

14 "Federal and Local Funds" shall mean all gifts,
15 grants, contributions, or entitlements, including grants by
16 the Congress of the United States, municipalities or counties.

17 Section 2. There is hereby appropriated the
18 amounts set forth herein for the ordinary expenses of the ex-
19 ecutive, legislative, and judicial agencies of the State, for
20 other functions of government, for debt service, and for capi-
21 tal outlay for the fiscal year ending September 30, 2013, to
22 be paid out of any monies hereinafter specified, from such
23 other funds and accounts as may be designated, or so much
24 thereof as may be necessary, and the total amount to be ex-
25 pended for the items for which the appropriation is herein
26 made shall not exceed the amount provided therefor, except as
27 provided in the Budget Management Act of 1976, Sections

41-19-1 through 41-19-12, Code of Alabama 1975. Provided, however, that regardless of the ending date of any pay period which has been or may be established by the Legislature for the payment of salaries of state employees, the entire payment due shall be made from the fiscal year's appropriation in which the pay date falls.

1 Section 3. RETIREMENT COSTS. The appropriations made
2 herein to departments, boards, offices, commissions, agencies

19 hereby appropriated to the State General Fund.

20 Section 12. All encumbered balances of a previous
21 fiscal year appropriation, other than the exclusions
22 authorized by this Act or in Section 41-4-93, Code of Alabama
23 1975, shall lapse no later than September 30 of the fiscal
24 year immediately following the fiscal year for which the
25 appropriation was made and shall revert to the credit of the
26 State General Fund or earmarked fund from which the
27 appropriation or appropriations were made.

1 Section 13. The appropriations made herein to the
2 departments, boards, offices, commissions and agencies include
3 the amounts necessary and said departments, boards, offices,
4 commissions and agencies are hereby directed to make the
5 transfer of funds to the State Personnel Department in said
6 amounts enumerated in this act. All agencies enumerated in
7 this act and receiving services from other governmental
8 agencies enumerated in this act shall make full payment in a
9 timely manner (as determined by the Department of Finance) for
10 such services.

11 Section 14. All funds collected under Section
12 40-12-43.1 between the effective date of Act 98-191 and
13 September 30, 2012 are hereby appropriated to the Auburn
14 University Center for Governmental Services for the
15 administration of the examiner certification program
16 established by the Alabama Local Tax Institute of Standards
17 and Training as provided in Section 40-12-43.1.

18 Section 15. It is the intent of the Legislature that
19 the funds appropriated to the Office of the Senate President
20 Pro Tempore in subsection 9 of Section 2A of this act which
21 are not otherwise designated may be expended by the Senate
22 President Pro Tempore for the same purposes as are authorized
23 for the Lieutenant Governor pursuant to Section 29-4-50 Code
24 of Alabama 1975, and the Speaker of the House of
25 Representatives pursuant to Section 29-4-60 Code of Alabama
26 1975.

1 Section 16. If merit pay increases are reinstated
2 after December 31, 2012, current anniversary dates will be
3 maintained for all state employees. Agencies are prohibited
4 from adjusting employee anniversary dates to obtain merit pay
5 increases at an earlier date.

6 Section 17. The appropriations made herein to the
7 departments, boards, offices, commissions and agencies include
8 the amounts necessary to pay the State Employee Health
9 Insurance Board (SEIB). The SEIB rate shall be \$765 per month
10 for each full-time employee for the fiscal year ending
11 September 30, 2013. The State Employees' Insurance Board will
12 adjust the insurance program wherever appropriate to maintain
13 the aforementioned fixed rate. For the fiscal year 2013, the
14 Governor upon the recommendation of the State Director of
15 Finance, shall have the authority to increase the SEIB monthly
16 employer insurance premium rate up to a maximum of \$805 per
17 month for each full-time employee.

18 Section 18. In the appropriation in this Act to the
19 Alabama Department of Public Health, the reference to Prostate
20 Screening and Research refers to research performed at the
21 Mitchell Cancer Institute. Of the above appropriation for
22 Prostate Screening and Research, \$300,000 shall go to the
23 Mitchell Cancer Institute with \$250,000 earmarked for cystic
24 fibrosis research and \$50,000 for prostate cancer research.

25 Section 19. It is the intent of the Legislature that
26 the Director of Finance shall notify the Chair of the House
27 Ways and Means General Fund Committee, the Chair of the Senate
