Citations Affected: IC 20-30.

Synopsis: School curriculum. Requires each school corporation and accredited nonpublic elementary school to include cursive writing in its curriculum. Requires each school corporation and accredited nonpublic school to include reading in its curriculum.

Effective: July 1, 2014.
