## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2005 – Talbot County –**  
3 **Frederick Douglass Memorial**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2005  
5 to extend the deadline by which the Frederick Douglass Memorial Action  
6 Coalition may present evidence to the Board of Public Works that a matching  
7 fund will be provided; and altering the matching fund requirement.

8 BY repealing and reenacting, with amendments,  
9 Chapter 445 of the Acts of the General Assembly of 2005

1 (BN) Frederick Douglass Memorial. Provide a grant equal to  
 2 the lesser of (i) \$100,000 or (ii) the amount of the  
 3 matching fund provided, to the Frederick Douglass  
 4 Memorial Action Coalition for the design and  
 5 construction of a monument to the life and legacy of  
 6 Frederick Douglass, to be located in Easton.  
 7 **NOTWITHSTANDING SECTION 1(5) OF THIS ACT,**  
 8 **THE MATCHING FUND MAY INCLUDE REAL**  
 9 **PROPERTY, IN KIND CONTRIBUTIONS, OR FUNDS**  
 10 **EXPENDED PRIOR TO THE EFFECTIVE DATE OF THIS**  
 11 **ACT AND THE GRANTEE HAS UNTIL JUNE 1, 2009,**  
 12 **TO PRESENT EVIDENCE THAT A MATCHING FUND**  
 13 **WILL BE PROVIDED (Talbot County)..... 100,000**

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 15 June 1, 2007.
