2 *An Act to amend and reenact § 54.1-2901 of the Code of Virginia, relating to an exemption from*  
3 *licensure for health professionals transporting patients to a neighboring state.*

6 **Be it enacted by the General Assembly of Virginia:**

7 **1. That § 54.1-2901 of the Code of Virginia is amended and reenacted as follows:**

8 § 54.1-2901. Exceptions and exemptions generally.

9 A. The provisions of this chapter shall not prevent or prohibit:

10 1. Any person entitled to practice his profession under any prior law on June 24, 1944, from  
11 continuing such practice within the scope of the definition of his particular school of practice;

12 2. Any person licensed to practice naturopathy prior to June 30, 1980, from continuing such practice  
13 in accordance with regulations promulgated by the Board;

14 3. Any licensed nurse practitioner from rendering care under the supervision of a duly licensed  
15 physician when such services are authorized by regulations promulgated jointly by the Board of  
16 Medicine and the Board of Nursing;

17 4. Any registered professional nurse, licensed nurse practitioner, graduate laboratory technician or  
18 other technical personnel who have been properly trained from rendering care or services within the  
19 scope of their usual professional activities which shall include the taking of blood, the giving of  
20 intravenous infusions and intravenous injections, and the insertion of tubes when performed under the  
21 orders of a person licensed to practice medicine;

22 5. Any dentist, pharmacist or optometrist from rendering care or services within the scope of his  
23 usual professional activities;

24 6. Any practitioner licensed or certified by the Board from delegating to personnel supervised by  
25 him, such activities or functions as are nondiscretionary and do not require the exercise of professional  
26 judgment for their performance and which are usually or customarily delegated to such persons by  
27 practitioners of the healing arts, if such activities or functions are authorized by and performed for such  
28 practitioners of the healing arts and responsibility for such activities or functions is assumed by such  
29 practitioners of the healing arts;

30 7. The rendering of medical advice or information through telecommunications from a physician  
31 licensed to practice medicine in Virginia or an adjoining state to emergency medical personnel acting in  
32 an emergency situation;

33 8. The domestic administration of family remedies;

34 9. The giving or use of massages, steam baths, dry heat rooms, infrared heat or ultraviolet lamps in  
35 public or private health clubs and spas;

36 10. The manufacture or sale of proprietary medicines in this Commonwealth by licensed pharmacists  
37 or druggists;

38 11. The advertising or sale of commercial appliances or remedies;

39 12. The fitting by nonitinerant persons or manufacturers of artificial eyes, limbs or other apparatus or  
40 appliances or the fitting of plaster cast counterparts of deformed portions of the body by a nonitinerant  
41 bracemaker or prosthetist for the purpose of having a three-dimensional record of the deformity, when  
42 such bracemaker or prosthetist has received a prescription from a licensed physician directing the fitting  
43 of such casts and such activities are conducted in conformity with the laws of Virginia;

44 13. Any person from the rendering of first aid or medical assistance in an emergency in the absence  
45 of a person licensed to practice medicine or osteopathy under the provisions of this chapter;

46 14. The practice of the religious tenets of any church in the ministrations to the sick and suffering by  
47 mental or spiritual means without the use of any drug or material remedy, whether gratuitously or for  
48 compensation;

49 15. Any legally qualified out-of-state or foreign practitioner from meeting in consultation with legally  
50 licensed practitioners in this Commonwealth;

51 16. Any practitioner of the healing arts licensed or certified and in good standing with the applicable  
52 regulatory agency in another state or Canada when that practitioner of the healing arts is in Virginia  
53 temporarily and such practitioner has been issued a temporary license or certification by the Board from  
54 practicing medicine or the duties of the profession for which he is licensed or certified (i) in a summer  
55 camp or in conjunction with patients who are participating in recreational activities, (ii) while  
56 participating in continuing educational programs prescribed by the Board, or (iii) by rendering at any

57 site any health care services within the limits of his license, voluntarily and without compensation, to  
58 any patient of any clinic which is organized in whole or in part for the delivery of health care services  
59 without charge as provided in § 54.1-106;

60 17. The performance of the duties of any commissioned or contract medical officer, or podiatrist in  
61 active service in the army, navy, coast guard, marine corps, air force, or public health service of the  
62 United States while such individual is so commissioned or serving;

63 18. Any masseur, who publicly represents himself as such, from performing services within the scope  
64 of his usual professional activities and in conformance with state law;

65 19. Any person from performing services in the lawful conduct of his particular profession or  
66 business under state law;

67 20. Any person from rendering emergency care pursuant to the provisions of § 8.01-225;

68 21. Qualified emergency medical services personnel, when acting within the scope of their  
69 certification, and licensed health care practitioners, when acting within their scope of practice, from  
70 following Durable Do Not Resuscitate Orders issued in accordance with § 54.1-2987.1 and Board of  
71 Health regulations, or licensed health care practitioners from following any other written order of a  
72 physician not to resuscitate a patient in the event of cardiac or respiratory arrest;

73 22. Any commissioned or contract medical officer of the army, navy, coast guard or air force  
74 rendering services voluntarily and without compensation while deemed to be licensed pursuant to  
75 § 54.1-106;

76 23. Any provider of a chemical dependency treatment program who is certified as an "acupuncture  
77 detoxification specialist" by the National Acupuncture Detoxification Association or an equivalent  
78 certifying body, from administering auricular acupuncture treatment under the appropriate supervision of  
79 a National Acupuncture Detoxification Association certified licensed physician or licensed acupuncturist;

80 24. Any employee of any assisted living facility who is certified in cardiopulmonary resuscitation  
81 (CPR) acting in compliance with the patient's individualized service plan and with the written order of  
82 the attending physician not to resuscitate a patient in the event of cardiac or respiratory arrest;

83 25. Any person working as a health assistant under the direction of a licensed medical or osteopathic  
84 doctor within the Department of Corrections, the Department of Juvenile Justice or local correctional  
85 facilities;

86 26. Any employee of a school board, authorized by a prescriber and trained in the administration of  
87 insulin and glucagon, when, upon the authorization of a prescriber and the written request of the parents  
88 as defined in § 22.1-1, assisting with the administration of insulin or administering glucagon to a  
89 student diagnosed as having diabetes and who requires insulin injections during the school day or for  
90 whom glucagon has been prescribed for the emergency treatment of hypoglycemia;

91 27. Any practitioner of the healing arts or other profession regulated by the Board from rendering  
92 free health care to an underserved population of Virginia who (i) does not regularly practice his  
93 profession in Virginia, (ii) holds a current valid license or certificate to practice his profession in another  
94 state, territory, district or possession of the United States, (iii) volunteers to provide free health care to  
95 an underserved area of this Commonwealth under the auspices of a publicly supported all volunteer,  
96 nonprofit organization that sponsors the provision of health care to populations of underserved people,  
97 (iv) files a copy of the license or certification issued in such other jurisdiction with the Board, (v)  
98 notifies the Board at least five business days prior to the voluntary provision of services of the dates and  
99 location of such service, and (vi) acknowledges, in writing, that such licensure exemption shall only be  
100 valid, in compliance with the Board's regulations, during the limited period that such free health care is  
101 made available through the volunteer, nonprofit organization on the dates and at the location filed with  
102 the Board. The Board may deny the right to practice in Virginia to any practitioner of the healing arts  
103 whose license or certificate has been previously suspended or revoked, who has been convicted of a  
104 felony or who is otherwise found to be in violation of applicable laws or regulations. However, the  
105 Board shall allow a practitioner of the healing arts who meets the above criteria to provide volunteer  
106 services without prior notice for a period of up to three days, provided the nonprofit organization  
107 verifies that the practitioner has a valid, unrestricted license in another state;

108 28. Any registered nurse, acting as an agent of the Department of Health, from obtaining specimens  
109 of sputum or other bodily fluid from persons in whom the diagnosis of active tuberculosis disease, as  
110 defined in § 32.1-49.1, is suspected and submitting orders for testing of such specimens to the Division  
111 of Consolidated Laboratories or other public health laboratories, designated by the State Health  
112 Commissioner, for the purpose of determining the presence or absence of tubercle bacilli as defined in  
113 § 32.1-49.1;

114 29. Any physician of medicine or osteopathy or nurse practitioner from delegating to a registered  
115 nurse under his supervision the screening and testing of children for elevated blood-lead levels when  
116 such testing is conducted (i) in accordance with a written protocol between the physician or nurse  
117 practitioner and the registered nurse and (ii) in compliance with the Board of Health's regulations

118 promulgated pursuant to §§ 32.1-46.1 and 32.1-46.2. Any follow-up testing or treatment shall be  
119 conducted at the direction of a physician or nurse practitioner;

120 30. Any practitioner of one of the professions regulated by the Board of Medicine who is in good  
121 standing with the applicable regulatory agency in another state or Canada from engaging in the practice  
122 of that profession when the practitioner is in Virginia temporarily with an out-of-state athletic team or  
123 athlete for the duration of the athletic tournament, game, or event in which the team or athlete is  
124 competing;

125 31. Any licensed nurse practitioner in the category of certified nurse midwife from rendering care in  
126 collaboration and consultation with a duly licensed physician when such services are authorized by  
127 regulations promulgated jointly by the Board of Medicine and the Board of Nursing; ~~or~~

128 32. Any person from performing state or federally funded health care tasks directed by the consumer,  
129 which are typically self-performed, for an individual who lives in a private residence and who, by  
130 reason of disability, is unable to perform such tasks but who is capable of directing the appropriate  
131 performance of such tasks; *or*

132 33. *Any practitioner of one of the professions regulated by the Board of Medicine who is in good*  
133 *standing with the applicable regulatory agency in another state from engaging in the practice of that*  
134 *profession in Virginia with a patient who is being transported to or from Virginia for care.*

135 B. Notwithstanding any provision of law or regulation to the contrary, a nurse practitioner licensed  
136 by the Boards of Nursing and Medicine in the category of certified nurse midwife may practice without  
137 the requirement for physician supervision while participating in a pilot program approved by the Board  
138 of Health pursuant to § 32.1-11.5.
