CHAPTER _____

1 AN ACT concerning

2 **Vehicle Laws – Prohibition Against Smoking in Vehicle Containing Young**
3 **Child**

4 FOR the purpose of prohibiting the driver of a motor vehicle in which a person who is
5 under a certain age is a passenger from smoking a tobacco product or allowing a
6 passenger to smoke in the motor vehicle; establishing a penalty for a violation of
7 this Act; providing that a violation of this Act is not a moving violation;
8 providing for the application of this Act; defining a certain term; and generally
9 relating to prohibitions against tobacco smoking in a motor vehicle.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article – Transportation**

18 **21–1130.**

1 **(A) IN THIS SECTION, "SMOKING" MEANS THE BURNING OF A LIGHTED**
2 **CIGARETTE, CIGAR, PIPE, OR ANY OTHER DEVICE OR SUBSTANCE THAT**
3 **CONTAINS TOBACCO.**

4 **(B) THE DRIVER OF A MOTOR VEHICLE IN WHICH A PERSON WHO IS**
5 **UNDER THE AGE OF 8 YEARS IS A PASSENGER MAY NOT ENGAGE IN SMOKING OR**
6 **ALLOW A PASSENGER TO ENGAGE IN SMOKING IN THE MOTOR VEHICLE.**

7 **(C) THIS SECTION DOES NOT APPLY TO A MOBILE HOME WHEN THE**
8 **MOBILE HOME IS BEING USED AS A PERMANENT OR TEMPORARY LIVING OR**
9 **SLEEPING PLACE AND NOT A CONVEYANCE ON HIGHWAYS.**

10 **(D) A VIOLATION OF THIS SECTION IS NOT A MOVING VIOLATION FOR**
11 **PURPOSES OF § 16-402 OF THIS ARTICLE.**

12 **27-115.**

13 **ANY PERSON CONVICTED OF A VIOLATION OF § 21-1130 OF THIS ARTICLE**
14 **IS SUBJECT TO A FINE OF NOT MORE THAN \$50.**

15 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**
16 **October 1, 2012.**
