- 2 REPRESENTATIVES OF THE STATE OF MISSISSIPPI IN ACCORDANCE WITH
- 3 SECTION 254, MISSISSIPPI CONSTITUTION OF 1890; AND FOR RELATED
- 4 PURPOSES.
- 5 WHEREAS, Section 254, Mississippi Constitution of 1890,
- 6 requires that the Mississippi Legislature shall apportion itself
- 7 by joint resolution in the second year following the 1980
- 8 decennial census and every ten (10) years thereafter; and
- 9 WHEREAS, it is the responsibility and official mandate of the
- 10 Legislature to reapportion the state in compliance with the
- 11 one-person, one-vote requirement of the federal Constitution into
- 12 election districts as nearly equal as possible according to
- 13 population and in accordance with other factors heretofore
- 14 pronounced by the courts; and
- WHEREAS, Section 254, Mississippi Constitution of 1890,
- 16 provides that the House of Representatives shall consist of not
- 17 more than one hundred twenty-two (122) representatives, the number
- 18 of members to be determined by the Legislature:
- 19 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
- 20 STATE OF MISSISSIPPI, That the Mississippi House of
- 21 Representatives shall consist of one hundred twenty-two (122)
- 22 representatives who shall be elected from one hundred twenty-two
- 23 (122) single-member districts, composed as follows:
