A BILL For

- 1 AN ACT relating to discrimination; prohibiting
- 2 discrimination based on sexual orientation or gender
- 3 identity as specified providing an exception; and providing
- 4 for an effective date.

6 Be It Enacted by the Legislature of the State of Wyoming:

8 **Section 1.** W.S. 6-9-104 is created to read:

10 6-9-104. Religious exemption.

11

- 12 (a) Nothing in this article or any other provision of
- 13 law related to discrimination in employment based on sexual

- ${\bf 1}$ orientation or gender identity shall be deemed to apply to any
- 2 of the employment practices of a religious corporation,
- 3 association, educational institution or society which has as
- 4 its primary purpose religious ritual or worship or the
- 5 teaching or spreading of religious doctrine or belief.

- 7 (b) For any religious corporation, association,
- 8 educational institution or society that is not wholly exempt
- 9 under subsection (a) of this section, this article or any
- 10 other provision of law related to discrimination in
- 11 employment based on sexual orientation or gender identity
- 12 shall not apply with respect to the employment of individuals
- 13 whose duties are ministerial, in that they consist of
- 14 teaching or spreading religious doctrine or belief, religious
- 15 governance, supervision of a religious order, supervision of
- 16 persons teaching or spreading religious doctrine or belief or
- 17 supervision or participation in religious ritual or worship.

- 19 (c) Nothing in this article or any other provision of
- 20 law related to discrimination based on sexual orientation or
- 21 gender identity shall be construed to limit the rights
- 22 available to a religious corporation, association,
- 23 educational institution or society under any federal law that

- 7 chairman elected every two (2) years thereafter.

- 11 (c) A charter school shall be subject to all federal
- 12 and state laws and constitutional provisions prohibiting
- 13 discrimination on the basis of disability, race, creed,

- 16 education services. Enrollment decisions shall be made in a
- 17 nondiscriminatory manner specified by the charter school
