# HOUSE BILL 2591

AN ACT

AMENDING SECTION 41-4602, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 46, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-4602.01; RELATING TO GOVERNMENTAL REPORTING OF INFORMATION.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 41-4602, Arizona Revised Statutes, is amended to  
3 read:

4 41-4602. Comprehensive internet web portal of local governments

5 The department of administration shall establish an internet web portal  
6 that provides a list of all local governments with jurisdiction over any  
7 address entered by a user. Each listing shall be linked to an agency website  
8 maintained by each local government that shall primarily contain the  
9 following information:

10 1. The name of the local government's governing board with official  
11 contact information for each board member, including a phone number for  
12 direct contact by constituents.

13 2. The name and contact information for the administrative head of the  
14 local government.

15 3. Information for how the governing board and administrative head of  
16 the local government are selected, including dates of the next election, if  
17 any, durations of terms and names and contact information of appointing  
18 authorities, as applicable.

19 4. Information on taxes or fees controlled by the local government and  
20 proposed changes in the taxes or fees.

21 5. Information on special elections, which shall be posted at least  
22 ninety days in advance of the election date.

23 6. A link to the official internet website required by section 41-725.

24 7. THE PREVIOUS YEAR'S ACTUAL BUDGET TOTAL, WHICH SHALL BE POSTED ON  
25 THE BOTTOM RIGHT-HAND CORNER OF THE AGENCY WEBSITE'S HOME PAGE. THE BUDGET  
26 INFORMATION SHALL BE UPDATED WITHIN NINETY DAYS AFTER THE END OF THE FISCAL  
27 YEAR.

28 Sec. 2. Title 41, chapter 46, article 1, Arizona Revised Statutes, is  
29 amended by adding section 41-4602.01, to read:

30 41-4602.01. State government's website; state budget

31 STATE GOVERNMENT SHALL POST THE PREVIOUS YEAR'S ACTUAL STATE BUDGET  
32 TOTAL ON THE BOTTOM RIGHT-HAND CORNER OF ITS WEBSITE'S HOME PAGE. THE BUDGET  
33 INFORMATION SHALL BE UPDATED WITHIN NINETY DAYS AFTER THE END OF THE FISCAL  
34 YEAR. THE BUDGET TOTAL SHALL SPECIFY THE AMOUNT OF MONIES THAT COME FROM THE  
35 GENERAL FUND, OTHER APPROPRIATED FUNDS AND FEDERAL FUNDS.
