- 1 A BILL for an Act to create and enact four new sections to chapter 15.1-37 of the North Dakota
- 2 Century Code, relating to early childhood education provider grants; to amend and reenact
- 3 section 15.1-37-01 of the North Dakota Century Code, relating to early childhood education
- 4 program approval; to provide an appropriation; and to provide an effective date.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 **SECTION 1. AMENDMENT.** Section 15.1-37-01 of the North Dakota Century Code is 7 amended and reenacted as follows:

8 **15.1-37-01. Early childhood education program - Approval.**

- Any person or school district operating an early childhood education program may
 request approval of the program from the superintendent of public instruction. The
 superintendent shall approve an early childhood education program if the program:
- a. Is taught by individuals who are licensed to teach in early childhood education by
 the education standards and practices board <u>or approved to teach in early</u>
- 14 childhood education by the education standards and practices board;
- b. Follows a developmentally appropriate curriculumeducational standards
 approved by the superintendent of public instruction;
- 17 c. Is in compliance with all municipal and state health, fire, and safety requirements;
 18 and
- d. Limits its enrollment to children who have reached the age of four before August
 first in the year of enrollment.
- 2. In determining the state aid payments to which a school district is entitled, the
 superintendent of public instruction may not count any student enrolled in a regular
 early childhood education program.

1 Data collection - Requirements.

- 2 The superintendent of public instruction, with the advice and consent of the department of
- 3 commerce, shall implement a uniform system for the accounting, budgeting, and reporting of
- 4 <u>data by any early childhood education provider to whom or to which grants are distributed in</u>
- 5 accordance with section 3 of this Act. Grants may be withheld or forfeited, in whole or in part, if
- 6 information required in accordance with this section is not submitted at the time or in the
- 7 <u>manner requested by the superintendent.</u>

8 SECTION 6. APPROPRIATION.

- 9 1. There is appropriated out of any moneys in the general fund in the state treasury, not
 10 otherwise appropriated, the sum of \$6,000,000, or so much of the sum as may be
 11 necessary, to the department of commerce for the purpose of providing early
- 12 childhood education grants, for the biennium beginning July 1, 2015, and ending13 June 30, 2017.
- If the amount appropriated in this section is insufficient to provide grants to all eligible
 providers, the department of commerce shall award the grants on a chronological
- 16 basis in accordance with the date on which a completed application is received.
- 17 SECTION 7. EFFECTIVE DATE. Sections 3 through 5 of this Act become effective on

18 July 1, 2016.
