## AN ACT

- 1 Regulating navigators and assisters in the education and
- 2 promotion of health insurance exchanges.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Navigator and
- 7 Exchange Assister Accessibility and Regulation Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Commissioner." The Insurance Commissioner of the
- 13 Commonwealth.
- 14 "Department." The Insurance Department of the Commonwealth.
- 15 "Exchange." A health insurance exchange established or
- 16 operating in this Commonwealth, including an exchange

- 1 established or operated by the United States Department of
- 2 Health and Human Services, under the Patient Protection and
- 3 Affordable Care Act (Public Law 111-148, 124 Stat. 119) FEDERAL <--

- 4 HEALTH CARE ACT.
- 5 "Exchange assister." An individual or organization,
- 6 including a navigator, navigator organization or certified
- 7 application counselor, who provides public education or assists
- 8 consumers for or on behalf of an exchange. This term does not
- 9 include a licensed insurance producer. This term shall DOES not <--
- 10 include an individual employed to provide insurance enrollment
- 11 or coverage assistance by a health care facility as defined in
- 12 section 103 of act of July 19, 1979 (P.L.130, No.48), known as
- 13 the Health Care Facilities Act.
- 14 "Federal health care act." The Patient Protection and
- 15 Affordable Care Act (Public Law 111-148, 124 Stat. 119), as
- 16 amended by the Health Care Education Reconciliation Act of 2010
- 17 (Public Law 111-152, 124 Stat. 1029), and regulations or
- 18 guidance issued under those acts.
- 19 "Health insurance producer." An insurance producer with an <--
- 20 accident and health line of authority as defined in section 601-
- 21 A of the act of May 17, 1921 (P.L.789, No.285), known as The
- 22 Insurance Department Act of 1921.
- "Insurance producer." Insurance producer has the meaning
- 24 given it in section 601-A of the act of May 17, 1921 (P.L.789,
- 25 No.285), known as The Insurance Department Act of 1921.
- 26 "Navigator." An organization or individual under the Federal
- 27 health care act that provides public education or consumer
- 28 assistance activities for or on behalf of an exchange to
- 29 uninsured individuals and groups seeking health insurance
- 30 coverage. The term shall include an individual performing

- 1 navigator duties for an organization, association or business
- 2 entity, if the organization, association or business entity is
- 3 serving as a navigator.
- 4 "Negotiate." The term has the same meaning given it in
- 5 section 601-A of the act of May 17, 1921 (P.L.789, No.285),
- 6 known as The Insurance Department Act of 1921.
- 7 "Registration." A registration certificate issued by the
- 8 department under section 3(c).
- 9 "Sell." The term has the same meaning given it in section
- 10 601-A of the act of May 17, 1921 (P.L.789, No.285), known as The
- 11 Insurance Department Act of 1921.
- "SHOP Exchange." The term has the same meaning given it in
- 13 the Federal health care act.
- 14 "Solicit." The term has the same meaning given it in section
- 15 601-A of the act of May 17, 1921 (P.L.789, No.285), known as The
- 16 Insurance Department Act of 1921.
- 17 Section 3. Registration.
- 18 (a) Prohibition. -- An individual or organization may not
- 19 advertise a service as a navigator or an exchange assister or
- 20 operate in this Commonwealth as a navigator or an exchange
- 21 assister without first registering with the department.
- 22 (b) Registration application. -- An individual or organization
- 23 shall register with the department as a navigator or exchange
- 24 assister, on a form approved by the department. The department
- 25 shall review each application and may conduct an investigation
- 26 of each applicant who applies for a registration in accordance
- 27 with this act. The department shall issue a registration, as
- 28 appropriate, to an applicant when the department determines that
- 29 the applicant:
- 30 (1) Is at least 18 years of age.

- 1 (2) Resides in this Commonwealth or maintains a 2 registered place of business in this Commonwealth.
- 3 (3) Is not disqualified for having committed an act that

would be grounds for denial, suspension or revocation of a

5 license as an insurance producer.

- 6 (4) Has not had a license as an insurance producer denied, suspended or revoked.
- 8 (5) Has submitted a completed application.
- 9 (6) Has submitted the applicant's fingerprints, for the 10 department to receive national criminal history records
- 11 information from the Criminal Justice Information Services
- 12 Division of the Federal Bureau of Investigation.
- 13 (7) Has paid the required registration fee and fees for
- 14 obtaining national criminal history records information
- as prescribed by the department.
- 16 (c) Confirmation. -- The department shall issue, in paper or
- 17 electronic form, a nontransferable registration certification to
- 18 each registered navigator or exchange assister, which shall
- 19 prominently list the expiration date of the registration and
- 20 which must be shown upon request to potential enrollees.
- 21 (d) Term.--The term of registration shall be two years from
- 22 the date of issue.
- 23 (e) Searchable list. -- The department shall maintain and make
- 24 available to the public a searchable list of all registrants on
- 25 its publicly accessible Internet website.
- 26 Section 4. Scope of activity.
- 27 (a) Registration required. -- An individual or organization
- 28 may not act or present itself to be a navigator or an exchange
- 29 assister unless the individual or organization is registered as
- 30 a navigator or an exchange assister under this act.

- 1 (b) Limitations.--A navigator or an exchange assister may
- 2 not engage in an activity for which licensure as a producer is
- 3 required, except as explicitly permitted by Federal law or
- 4 regulation, including any of the following:
- 5 (1) Sell, solicit or negotiate insurance.
- 6 (2) Urge or advise a prospective purchaser to buy a
- 7 particular policy or to insure with a particular company.
- 8 (3) Initiate sales over the telephone or otherwise.
- 9 (4) Collect premiums.
- 10 (5) Make or propose to make an insurance contract.
- 11 (6) Other than as necessary to inform a prospective
- 12 purchaser of the availability of health insurance off the
- exchange, provide information or services related to health
- benefit plans or other products other than those offered in
- the health insurance marketplace, SHOP Exchange, the
- 16 Children's Health Insurance Program or product available
- through the Social Security Act (49 Stat. 620, 42 U.S.C. §
- 18 301 et seq.).
- 19 (7) Initiate an inquiry as to the terms of existing
- 20 coverage.
- 21 (8) Recommend or initiate additions or deletions to an
- insured's policy.
- 23 (9) Sign binders, endorsements and insurance policies.
- 24 (10) Authorize the issuance or delivery of certificates
- of insurance, endorsements, binders or insurance policies on
- 26 insurance identification cards.
- 27 (11) Respond to a policyholder's request for advice or
- counsel regarding policy provisions or coverage.
- 29 Section 5. Enforcement by department.
- 30 (a) Notice.--Upon evidence of a violation of this act or

- 1 Article VI-A of the act of May 17, 1921 (P.L.789, No.285), known
- 2 as The Insurance Department Act of 1921, the department shall
- 3 notify the person of the alleged violation. The notice shall
- 4 specify the nature of the alleged violation and fix a time and
- 5 place, at least 10 days thereafter, when a hearing on the matter
- 6 shall be held.
- 7 (b) Hearing. -- The department shall conduct the hearing on
- 8 the violation in accordance with 2 Pa.C.S. Ch. 5 Subch. A
- 9 (relating to practice and procedure of Commonwealth agencies).

- 10 (c) Evidence. -- A person shall MAY not be excused from
- 11 testifying or from producing any books, papers, contracts,
- 12 agreements or documents at any hearing held by the commissioner
- 13 on the ground that the testimony or evidence may tend to
- 14 incriminate that person.
- 15 (d) Penalties. -- After the hearing or upon failure of the
- 16 person to appear at the hearing, if a violation is found, the
- 17 commissioner may, in addition to any penalty which may be
- 18 imposed by a court, do any combination of the following deemed
- 19 appropriate:
- 20 (1) Deny, suspend, refuse to renew or revoke the
- 21 registration, if any, of the person.
- 22 (2) Impose a civil penalty of up to \$5,000 for each
- 23 violation of this act.
- 24 (3) Impose an order to cease and desist.
- 25 (4) Report violations of this act to the United States
- 26 Department of Health and Human Services.
- 27 (5) Refer potential violations of any laws of this
- 28 Commonwealth relating to privacy of personal information to
- 29 the Office of Attorney General.
- 30 (6) Enforce other violations of The Insurance Department

- 1 Act of 1921, as applicable.
- 2 (7) Impose any other conditions the commissioner deems
- 3 appropriate.
- 4 (e) Regulations and form. -- The department may promulgate
- 5 regulations and publish forms as necessary and appropriate to
- 6 carry out this act.
- 7 Section 6. Effective date.
- 8 This act shall take effect February 15, 2016, or the close of
- 9 the 2016 open enrollment period, whichever is later.
