AN ACT concerning social welfare; Kansas department for children and families; eligibility requirements for assistance; amending K.S.A. 17-2263, 17-5828, 39-709b, 59-1301 and 59-3504 and K.S.A. 2014 Supp. 9-1215, 9-1216, 16-311, 17-2264, 17-5829, 39-702, 39-709, 39-709c, 39-753, 39-756a, 59-2222, 59-2247, 59-2801 and 59-3086 and repealing the existing sections; also repealing K.S.A. 39-7,101, 39-7,106, 39-7,107, 39-7,110 and 75-5364 and K.S.A. 2014 Supp. 39-7,102, 39-7,103, 39-7,104, 39-7,105, 39-7,108, 39-7,109 and 39-7,122.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 2014 Supp. 9-1215 is hereby amended to read as follows: 9-1215. Subject to the provisions of this section and K.S.A. 9-1216, and amendments thereto, an individual adult or minor, hereafter referred to as the owner, may enter into a written contract with any bank located in this state providing that the balance of the owner's deposit account, or the balance of the owner's legal share of a deposit account, at the time of death of the owner shall be made payable on the death of the owner to one or more persons or, if the persons predecease the owner, to another person or persons, hereafter referred to as the beneficiary or beneficiaries. If any beneficiary is a minor at the time the account, or any portion of the account, becomes payable to the beneficiary and the balance, or portion of the balance, exceeds the amount specified by K.S.A. 59-3053, and amendments thereto, the moneys shall be payable only to a conservator of the minor beneficiary.

Transfers pursuant to this section shall not be considered testamentary or be invalidated due to nonconformity with the provisions of chapter 59 of the Kansas Statutes Annotated, *and amendments thereto*.

Every contract authorized by this section shall be considered to contain a right on the part of the owner during the owner's lifetime both to withdraw funds on deposit in the account in the manner provided in the contract, in whole or in part, as though no beneficiary has been named, and to change the designation of beneficiary. The interest of the beneficiary shall be considered not to vest until the death of the owner and, if there is a claim pursuant to ~~subsection (g)~~ of K.S.A. 39-709, and amendments thereto, until such claim is satisfied.

No change in the designation of the beneficiary shall be valid unless

1 executed in the form and manner prescribed by the bank and delivered to
2 the bank prior to the death of the owner.

3 For the purposes of this section, the balance of the owner's deposit
4 account or the balance of the owner's legal share of a deposit account shall
5 not be construed to include any portion of the account which under the law
6 of joint tenancy is the property of another joint tenant of the account upon
7 the death of the owner.

8 As used in this section, "person" means any individual, individual or
9 corporate fiduciary or nonprofit religious or charitable organization as
10 defined by K.S.A. 79-4701, and amendments thereto.

11 Sec. 2. K.S.A. 2014 Supp. 9-1216 is hereby amended to read as
12 follows: 9-1216. When the owner and the bank have entered into a
13 contract authorized in K.S.A. 9-1215, and amendments thereto, the
14 owner's deposit account subject to the contract or any part of or interest on
15 the account shall be paid by the bank to the owner or pursuant to the
16 owner's order during the owner's lifetime. On the owner's death, the
17 deposit account or any part of or interest on the account shall be paid by
18 the bank to the secretary for children and families for a claim pursuant to
19 ~~subsection (g)~~ of K.S.A. 39-709, and amendments thereto, or, if there is no
20 such claim or if any portion of the account remains after such claim is
21 satisfied, to the designated beneficiary or beneficiaries. If any designated
22 beneficiary is a minor at the time the account, or any portion of the
23 account, becomes payable to the beneficiary and the balance, or portion of
24 the balance, exceeds the amount specified by K.S.A. 59-3053, and
25 amendments thereto, the bank shall pay the moneys or any interest on
26 them only to a conservator of the minor beneficiary. The receipt of the
27 conservator shall release and discharge the bank for the payment.

28 Sec. 3. K.S.A. 2014 Supp. 16-311 is hereby amended to read as
29 follows: 16-311. (a) Whenever a person, who is or has been a recipient of
30 medical assistance from the Kansas department for children and families,
31 enters into a prearranged funeral agreement, contract or plan pursuant to
32 K.S.A. 16-301, and amendments thereto, or a prearranged funeral
33 agreement, contract or plan funded by insurance proceeds, such person
34 shall inform the secretary for children and families or the secretary's
35 designee of the existence of such an agreement, contract or plan and shall
36 inform the funeral establishment that such person is or has been a recipient
37 of medical assistance.

38 (b) If any balance remains after payment for the final disposition of a
39 dead human body, or for funeral or burial services, or funeral or burial
40 merchandise, and the purchaser of the agreement, contract, or plan is or
41 has been a recipient of medical assistance or a deceased surviving spouse
42 of a recipient of medical assistance, any remaining balance shall be paid
43 according to K.S.A. 16-304, and amendments thereto, or if such

1 agreement, contract or plan was funded by insurance, any remaining
2 balance shall be paid by the insurance company or the person, association,
3 partnership, firm or corporation providing the services or merchandise to
4 the secretary for children and families or the secretary's designee, to the
5 extent of medical assistance expended on the deceased recipient. The
6 insurance company or the person, association, partnership, firm or
7 corporation providing the services or merchandise shall not be liable to the
8 Kansas department for children and families for the balance in the account
9 if written notice has not been received stating that medical assistance has
10 been expended on the recipient for which the Kansas department for
11 children and families may have a claim, and the balance of the account has
12 been paid to the estate of the deceased or in the case of insurance, the
13 designated beneficiary.

14 (c) Payments to the secretary for children and families under
15 subsection (b) and K.S.A. 16-304, and amendments thereto, shall be
16 governed by ~~subsection (g)(2) of K.S.A. 39-709~~, and amendments thereto.

17 Sec. 4. K.S.A. 17-2263 is hereby amended to read as follows: 17-
18 2263. Subject to the provisions of this section and K.S.A. 17-2264, and
19 amendments thereto, an individual adult or minor, hereafter referred to as
20 the shareholder, may enter into a written contract with any credit union
21 located in this state providing that the balance of the shareholder's account,
22 or the balance of the shareholder's legal share of an account, at the time of
23 death of the shareholder shall be made payable on the death of the
24 shareholder to one or more persons or, if the persons predecease the owner,
25 to another person or persons, hereafter referred to as the beneficiary or
26 beneficiaries. If any beneficiary is a minor at the time the account, or any
27 portion of the account, becomes payable to the beneficiary and the
28 balance, or portion of the balance, exceeds the amount specified by K.S.A.
29 59-3053, and amendments thereto, the moneys shall be payable only to a
30 conservator of the minor beneficiary.

31 Transfers pursuant to this section shall not be considered testamentary
32 or be invalidated due to nonconformity with the provisions of chapter 59
33 of the Kansas Statutes Annotated, *and amendments thereto*.

6 the death of the owner.

7 As used in this section, "person" means any individual, individual or
8 corporate fiduciary or nonprofit religious or charitable organization as
9 defined by K.S.A. 79-4701, and amendments thereto.

10 Sec. 5. K.S.A. 2014 Supp. 17-2264 is hereby amended to read as
11 follows: 17-2264. When the shareholder and the credit union have entered
12 into a contract authorized in K.S.A. 17-2263, and amendments thereto, the
13 shareholder's account subject to the contract or any part of or interest on
14 the account shall be paid by the credit union to the shareholder or pursuant
15 to the shareholder's order during the shareholder's lifetime. On the
16 shareholder's death, the deposit account or any part of or interest on the
17 account shall be paid by the credit union to the secretary for children and
18 families for a claim pursuant to ~~subsection (g) of~~ K.S.A. 39-709, and
19 amendments thereto, or, if there is no such claim or if any portion of the
20 account remains after such claim is satisfied, to the designated beneficiary
21 or beneficiaries. If any designated beneficiary is a minor at the time the
22 account, or any portion of the account, becomes payable to the beneficiary
23 and the balance, or portion of the balance, exceeds the amount specified by
24 K.S.A. 59-3053, and amendments thereto, the credit union shall pay the
25 moneys or any interest on them only to a conservator of the minor
26 beneficiary. The receipt of the conservator shall release and discharge the
27 credit union for the payment.

28 Sec. 6. K.S.A. 17-5828 is hereby amended to read as follows: 17-
29 5828. Subject to the provisions of this section and K.S.A. 17-5829, and
30 amendments thereto, an individual adult or minor, hereafter referred to as
31 the owner, may enter into a written contract with any savings and loan
32 association located in this state providing that the balance of the owner's
33 deposit account, or the balance of the owner's legal share of a deposit
34 account, at the time of death of the owner shall be made payable on the
35 death of the owner to one or more persons or, if the persons predecease the
36 owner, to another person or persons, hereafter referred to as the beneficiary
37 or beneficiaries. If any beneficiary is a minor at the time the account, or
38 any portion of the account, becomes payable to the beneficiary and the
39 balance, or portion of the balance, exceeds the amount specified by K.S.A.
40 59-3053, and amendments thereto, the moneys shall be payable only to a
41 conservator of the minor beneficiary.

23 follows: 17-5829. When the owner and the savings and loan association
24 have entered into a contract authorized in K.S.A. 17-5828, and
25 amendments thereto, the owner's deposit account subject to the contract or
26 any part of or interest on the account shall be paid by the savings and loan
27 association to the owner or pursuant to the owner's order during the
28 owner's lifetime. On the owner's death, the deposit account or any part of
29 or interest on the account may be paid by the savings and loan association
30 to the secretary for children and families for a claim pursuant to ~~subsection~~
31 ~~(g) of~~ K.S.A. 39-709, and amendments thereto, or, if there is no such claim
32 or if any portion of the account remains after such claim is satisfied, to the
33 designated beneficiary or beneficiaries. If any designated beneficiary is a
34 minor at the time the account, or any portion of the account, becomes
35 payable to the beneficiary and the balance, or portion of the balance,
36 exceeds the amount specified by K.S.A. 59-3053, and amendments
37 thereto, the savings and loan association shall pay the moneys or any
38 interest on them only to a conservator of the minor beneficiary. The receipt
39 of the conservator shall release and discharge the savings and loan

41 Sec. 8. K.S.A. 2014 Supp. 39-702 is hereby amended to read as
42 follows: 39-702. The following words and phrases when used in this act
43 shall, for the purposes of this act, have the meanings respectively ascribed

1 to them in this section:

2 (a) "Secretary" means the secretary for children and families, unless
3 otherwise specified.

4 (b) "Applicants" means all persons who, as individuals, or in whose
5 behalf requests are made of the secretary for aid or assistance.

6 (c) "Social welfare service" may include such functions as giving
7 assistance, the prevention of public dependency, and promoting the
8 rehabilitation of dependent persons or those who are approaching public
9 dependency.

10 (d) "Assistance" includes such items or functions as the giving or
11 providing of money, food ~~stamps or coupons~~ assistance, food, clothing,
12 shelter, medicine or other materials, the giving of any service, including
13 instructive or scientific, ~~and the providing of institutional care, which may~~
14 ~~be necessary or helpful to the recipient in providing the necessities of life~~
15 ~~for the recipient and the recipient's dependents.~~ The definitions of social
16 welfare service and assistance in this section shall be deemed as partially
17 descriptive and not limiting.

18 (e) ~~"Aid to families with dependent children"~~ *Temporary assistance to*
19 *needy families*" means financial assistance with respect to or on behalf of a
20 dependent child or dependent children and includes financial assistance for
21 any month to meet the needs of the relative *or qualifying caretaker* with
22 whom any dependent child is living.

23 (f) "Medical assistance" means the payment of all or part of the cost
24 of necessary: (1) Medical, remedial, rehabilitative or preventive care and
25 services which are within the scope of services to be provided under a
26 medical care plan developed by the secretary pursuant to this act and
27 furnished by health care providers who have a current approved provider
28 agreement with the secretary; and (2) transportation to obtain care and
29 services which are within the scope of services to be provided under a
30 medical care plan developed by the secretary pursuant to this act.

31 (g) "Dependent children" means needy children under the age of 18,
32 or who are under the age of 19 and are full-time students in secondary
33 schools or the equivalent educational program ~~or are full-time students in a~~
34 ~~program of vocational or technical training if they may be reasonably~~
35 ~~expected to complete the training before attaining age 19, who have been~~
36 ~~deprived of parental or guardian support or care by reasons of the death,~~
37 ~~continued absence from the home, or physical or mental incapacity who~~
38 ~~are in the care of a biological or adoptive parent or, court appointed~~
39 ~~guardian, conservator or legal custodian and who are living with any~~
40 ~~blood relative, including those of the half blood, and including first~~
41 ~~cousins, uncles, aunts, and persons of preceding generations are denoted~~
42 ~~by prefixes of grand, great, or great-great, and including the spouses or~~
43 ~~former spouses of any persons named in the above groups, in a place of~~

1 residence maintained by one or more of such relatives as their own home.
2 ~~The secretary may adopt rules and regulations which extend the~~
3 ~~deprivation requirement under this definition to include being deprived of~~
4 ~~parental or guardian support or care by reason of the unemployment of a~~
5 ~~parent or guardian. The term "dependent children" also includes children~~
6 ~~who would meet the foregoing requirements except for their removal from~~
7 ~~the home of a relative as a result of judicial determination to the effect that~~
8 ~~continuation therein would be contrary to the welfare of such children, for~~
9 ~~whose placement and care the secretary is responsible, who have been~~
10 ~~placed in a foster family home or child care institution as a result of such~~
11 ~~determination and who received aid to dependent children in or for the~~

20 (h) "The blind" means not only those who are totally and permanently
21 devoid of vision, but also those persons whose vision is so defective as to
22 prevent the performance of ordinary activities for which eyesight is
23 essential.

24 (i) ~~"General assistance" means financial assistance in which the cost~~
25 ~~of such financial assistance is not participated in by the federal~~
26 ~~government. General assistance may be limited to transitional assistance in~~
27 ~~some instances as specified by rules and regulations adopted by the~~
28 ~~secretary.~~

29 ~~(j)~~—"Recipient" means a person who has received assistance under the
30 terms of this act.

31 ~~(k)~~-(j) "Intake office" means the place where the secretary shall
32 maintain an office for receiving applications.

33 ~~(l)~~-(k) "Adequate consideration" means consideration equal, or
34 reasonably proportioned to the value of that for which it is given.

35 ~~(m)~~—"Transitional assistance" means a form of general assistance in
36 which as little financial assistance as one payment may be made during
37 each period of 12 consecutive calendar months to an eligible and needy
38 person and all other persons for whom such person is legally responsible.

39 ~~(n)~~-(l) "Title IV-D" means part D of title IV of the federal social
40 security act (42 U.S.C. § 651 et seq.), as in effect on May 1, 1997.

41 (m) *"TANF diversion assistance" means a one-time voluntary*
42 *payment option in lieu of ongoing TANF assistance. The diversion*
43 *payment is available to applicants who have not received TANF assistance*

1 *as an adult, and is designed to meet a crisis or emergency hardship that*
2 *would endanger such applicants' ability to remain employed or to accept*
3 *an offer of employment. Any household that includes such recipient*
4 *accepting the diversion payment is ineligible to receive on-going TANF*
5 *assistance for 12 months after receipt of the diversion payment. Any*
6 *recipient who receives a diversion payment is limited to 42 months of*
7 *TANF cash assistance in a lifetime, unless such recipient shall meet a*
8 *hardship criteria as defined by the secretary.*

9 (n) *"Non-cooperation" means the failure of the applicant or recipient*
10 *to comply with all requirements provided in state and federal law, rules*
11 *and regulations and agency policy.*

12 Sec. 9. K.S.A. 2014 Supp. 39-709 is hereby amended to read as
13 follows: 39-709. (a) *General eligibility requirements for assistance for*
14 *which federal moneys are expended.* Subject to the additional requirements
15 below, assistance in accordance with plans under which federal moneys
16 are expended may be granted to any needy person who:

17 (1) Has insufficient income or resources to provide a reasonable
18 subsistence compatible with decency and health. Where a husband and
19 wife or *cohabiting partners* are living together, the combined income or
20 resources of both shall be considered in determining the eligibility of
21 either or both for such assistance unless otherwise prohibited by law. The
22 secretary, in determining need of any applicant for or recipient of
23 assistance shall not take into account the financial responsibility of any
24 individual for any applicant or recipient of assistance unless such applicant
25 or recipient is such individual's spouse, *cohabiting partner* or such
26 individual's minor child or minor stepchild if the stepchild is living with
27 such individual. The secretary in determining need of an individual may
28 provide such income and resource exemptions as may be permitted by
29 federal law. For purposes of eligibility ~~for aid for families with dependent~~
30 ~~children~~ *temporary assistance for needy families, for food—stamp—*
31 *assistance and for any other assistance provided through the Kansas*
32 *department for children and families under which federal moneys are*
33 *expended, the secretary for children and families shall consider one motor*
34 *vehicle owned by the applicant for assistance, regardless of the value of*
35 *such vehicle, as exempt personal property and shall consider any equity in*
36 *any boat, personal water craft, recreational vehicle, recreational off-*
37 *highway vehicle or all-terrain vehicle, as defined by K.S.A. 8-126, and*
38 *amendments thereto, or any additional motor vehicle owned by the*
39 *applicant for assistance to be a nonexempt resource of the applicant for*
40 *assistance except that any additional motor vehicle used by the applicant,*
41 *the applicant's spouse or the applicant's cohabiting partner for the*
42 *primary purpose of earning income may be considered as exempt personal*
43 *property in the secretary's discretion.*

1 (2) Is a citizen of the United States or is an alien lawfully admitted to
2 the United States and who is residing in the state of Kansas.

3 (b) ~~Assistance to families with dependent children. Assistance may be~~
4 ~~granted under this act to any dependent child, or relative, subject to the~~
5 ~~general eligibility requirements as set out in subsection (a), who resides in~~
6 ~~the state of Kansas or whose parent or other relative with whom the child~~
7 ~~is living resides in the state of Kansas. Such assistance shall be known as~~
8 ~~aid to families with dependent children. Where husband and wife are~~
9 ~~living together both shall register for work under the program~~
10 ~~requirements for aid to families with dependent children in accordance~~
11 ~~with criteria and guidelines prescribed by rules and regulations of the~~
12 ~~secretary.~~ *Temporary assistance for needy families. Assistance may be*
13 *granted under this act to any dependent child, or relative, subject to the*
14 *general eligibility requirements as set out in subsection (a), who resides in*
15 *the state of Kansas or whose parent or other relative with whom the child*
16 *is living resides in the state of Kansas. Such assistance shall be known as*
17 *temporary assistance for needy families. {On and after January 1, 2017,*
18 *the department shall conduct an electronic check for any false*
19 *information provided on an application for TANF and other benefits*
20 *programs administered by the department.}* *Where the husband and wife*
21 *or cohabiting partners are living together, both shall register for work*
22 *under the program requirements for temporary assistance for needy*
23 *families in accordance with criteria and guidelines prescribed by rules*
24 *and regulations of the secretary.*

25 (1) *As used in this subsection, "family group" or "household" means*
26 *the applicant or recipient for TANF, child care subsidy or employment*
27 *services and all individuals living together in which there is a relationship*
28 *of legal responsibility or a qualifying caretaker relationship. This will*
29 *include a cohabiting boyfriend or girlfriend living with the person legally*
30 *responsible for the child. The family group shall not be eligible for TANF*
31 *if the family group contains at least one adult member who has received*
32 *TANF, including the federal TANF assistance received in any other state,*
33 *for 36 calendar months beginning on and after October 1, 1996, unless the*
34 *secretary determines a hardship exists and grants an extension allowing*
35 *receipt of TANF until the 48-month limit is reached. No extension beyond*
36 *48 months shall be granted. Hardship provisions for a recipient include:*

37 (A) *Is a caretaker of a disabled family member living in the*
38 *household;*

39 (B) *has a disability which precludes employment on a long-term*
40 *basis or requires substantial rehabilitation;*

41 (C) *needs a time limit extension to overcome the effects of domestic*
42 *violence/sexual assault;*

43 (D) *is involved with prevention and protection services (PPS) and*

1 *has an open social service plan; or*

2 *(E) is determined by the 36th month to have an extreme hardship*
3 *other than what is designated in criteria listed in subparagraphs (A)*
4 *through (E). This determination will be made by the executive review*
5 *team.*

6 *(2) All adults applying for TANF shall be required to complete a*
7 *work program assessment as specified by the Kansas department for*
8 *children and families, including those who have been disqualified for or*
9 *denied TANF due to non-cooperation, drug testing requirements or fraud.*
10 *Adults who are not otherwise eligible for TANF, such as ineligible aliens,*
11 *relative/non-relative caretakers and adults receiving supplemental security*
12 *income are not required to complete the assessment process. During the*
13 *application processing period, applicants must complete at least one*
14 *module or its equivalent of the work program assessment to be considered*
15 *eligible for TANF benefits, unless good cause is found to be exempt from*
16 *the requirements. Good cause exemptions shall only include:*

17 *(A) The applicant can document an existing certification verifying*
18 *completion of the work program assessment;*

19 *(B) the applicant has a valid offer of employment or is employed a*
20 *minimum of 20 hours a week;*

21 *(C) the applicant is a parenting teen without a GED or high school*
22 *diploma;*

23 *(D) the applicant is enrolled in job corps;*

24 *(E) the applicant is working with a refugee social services agency; or*

25 *(F) the applicant has completed the work program assessment within*
26 *the last 12 months.*

27 *(3) The department for children and families shall maintain a*
28 *sufficient level of dedicated work program staff to enable the agency to*
29 *conduct work program case management services to TANF recipients in a*
30 *timely manner and in full accordance with state law and agency policy.*

31 *(4) TANF mandatory work program applicants and recipients shall*
32 *participate in work components that lead to competitive, integrated*
33 *employment. Components are defined by the federal government as being*
34 *either primary or secondary. In order to meet federal work participation*
35 *requirements, households need to meet at least 30 hours of participation*
36 *per week, at least 20 hours of which need to be primary and at least 10*
37 *hours may be secondary components {in one parent households where*
38 *the youngest child is six years of age or older. Participation hours shall*
39 *be 55 hours in two parent households (35 hours per week if child care is*
40 *not used). The maximum assignment is 40 hours per week per*
41 *individual. For two parent families to meet the federal work*
42 *participation rate both parents must participate in a combined total of 55*
43 *hours per week, 50 hours of which must be in primary components, or*

1 *one or both parents could be assigned a combined total of 35 hours per*
2 *week (30 hours of which must be primary components) if department for*
3 *children and families paid child care is not received by the family. Single*
4 *parent families with a child under age six meet the federal participation*
5 *requirement if the parent is engaged in work or work activities for at*
6 *least 20 hours per week in a primary work component}. The following*
7 *components meet federal definitions of primary hours of participation:*
8 *Full or part-time employment, apprenticeship, work study, self-*
9 *employment, job corps, subsidized employment, work experience sites, on-*
10 *the-job training, supervised community service, vocational education, job*
11 *search and job readiness. Secondary components include: Job skills*
12 *training, education directly related to employment such as adult basic*
13 *education and English as a second language, and completion of a high*
14 *school diploma or GED.*

15 (5) *A parent or other adult caretaker personally providing care for a*
16 *child under the age of three months in their TANF household is exempt*
17 *from work participation activities until the month the child turns three*
18 *months of age. Such three-month limitation shall not apply to a parent or*
19 *other adult caretaker who is personally providing care for a child born*
20 *significantly premature, with serious medical conditions or with a*
21 *disability as defined by the secretary, in consultation with the secretary of*
22 *health and environment, and adopted in the rules and regulations. The*
23 *three-month period is defined as two consecutive months starting with the*
24 *month after childbirth. The exemption for caring for a child under three*
25 *months cannot be claimed:*

26 (A) *By either parent when two parents are in the home and the*
27 *household meets the two-parent definition for federal reporting purposes;*

28 (B) *by one parent or caretaker when the other parent or caretaker is*
29 *in the home, and available, capable and suitable to provide care and the*
30 *household does not meet the two-parent definition for federal reporting*
31 *purposes;*

32 (C) *by a person age 19 or younger when such person is pregnant or a*
33 *parent of a child in the home and the person does not possess a high*
34 *school diploma or its equivalent. Such person shall become exempt the*
35 *month such person turns age 20;*

36 (D) *by any adult in the TANF assistance plan when at least one adult*
37 *has reached the 36 months of TANF cash assistance; or*

38 (E) *by any person assigned to a work participation activity for*
39 *substance use disorders.*

40 (6) *TANF work experience placements shall be reviewed after 90*
41 *days and are limited to six months per 48-month lifetime limit. A client's*
42 *progress shall be reviewed prior to each new placement regardless of the*
43 *length of time they are at the work experience site.*

1 (7) *TANF participants with disabilities shall engage in required*
2 *employment activities to the maximum extent consistent with their*
3 *abilities. TANF participants shall provide current documentation by a*
4 *qualified medical practitioner that details the abilities to engage in*
5 *employment and any limitations in work activities along with the expected*
6 *duration of such limitations. Disability is defined as a physical or mental*
7 *impairment constituting or resulting in a substantial impediment to*
8 *employment for such individual.*

9 (8) *Non-cooperation is the failure of the applicant or recipient to*
10 *comply with all requirements provided in state and federal law, federal*
11 *and state rules and regulations and agency policy. The period of*
12 *ineligibility for TANF benefits based on non-cooperation with work*
13 *programs shall be as follows:*

14 (A) *For a first penalty, three months and full cooperation with work*
15 *program activities;*

16 (B) *for a second penalty, six months and full cooperation with work*
17 *program activities;*

18 (C) *for a third penalty, one year and full cooperation with work*
19 *program activities; and*

20 (D) *for a fourth or subsequent penalty, 10 years.*

21 (9) *Individuals that have not cooperated with TANF work programs*
22 *shall be ineligible to participate in the food assistance program. The*
23 *comparable penalty shall be applied to only the individual in the food*
24 *assistance program who failed to comply with the TANF work*
25 *requirement. The agency shall impose the same penalty to the member of*
26 *the household who failed to comply with TANF requirements. The penalty*
27 *periods are three months, six months, one year, or 10 years.*

28 (10) *Non-cooperation is the failure of the applicant or recipient to*
29 *comply with all requirements provided in state and federal law, federal*
30 *and state rules and regulations and agency policy. The period of*
31 *ineligibility for child care subsidy or TANF benefits based on parents' non-*
32 *cooperation with child support services shall be as follows:*

33 (A) *For the first penalty, three months and cooperation with child*
34 *support services prior to regaining eligibility;*

35 (B) *for a second penalty, six months and cooperation with child*
36 *support services prior to regaining eligibility;*

37 (C) *for a third penalty, one year and cooperation with child support*
38 *services prior to regaining eligibility; and*

39 (D) *for a fourth penalty, 10 years.*

40 (11) *Individuals that have not cooperated without good cause with*
41 *child support services shall be ineligible to participate in the food*
42 *assistance program. The period of disqualification ends once it has been*
43 *determined that such individual is cooperating with child support services.*

1 (12) *Any individual who is found to have committed fraud or is found*
2 *guilty of the crime of theft pursuant to K.S.A. 39-720 and K.S.A. 2014*
3 *Supp. 21-5801, and amendments thereto, in either the TANF or child care*
4 *program shall render all adults in the family unit ineligible for TANF*
5 *assistance. Adults in the household who were determined to have*
6 *committed fraud or were convicted of the crime of theft pursuant to K.S.A.*
7 *39-720 and K.S.A. 2014 Supp. 21-5801, and amendments thereto, shall*
8 *render themselves and all adult household members ineligible for their*
9 *lifetime for TANF, even if fraud was committed in only one program.*
10 *Households who have been determined to have committed fraud or were*
11 *convicted of the crime of theft pursuant to K.S.A. 39-720 and K.S.A. 2014*
12 *Supp. 21-5801, and amendments thereto, shall be required to name a*
13 *protective payee as approved by the secretary or the secretary's designee*
14 *to administer TANF benefits {or food assistance} on behalf of the children.*
15 *No adult in a household may have access to the TANF cash assistance*
16 *benefit.*

17 (13) (A) *Food assistance shall not be provided to any person*
18 *convicted of a felony offense occurring on or after July 1, 2015, which*
19 *includes as an element of such offense the manufacture, cultivation,*
20 *distribution, possession or use of a controlled substance or controlled*
21 *substance analog. For food assistance, the individual shall be*
22 *permanently disqualified if they have been convicted of a state or federal*
23 *felony offense occurring on or after July 1, 2015, involving possession or*
24 *use of a controlled substance or controlled substance analog.*

25 (B) *Notwithstanding the provisions of subparagraph (A), an*
26 *individual shall be eligible for food assistance if the individual enrolls in*
27 *and participates in a drug treatment program approved by the secretary,*
28 *submits to and passes a drug test and agrees to submit to drug testing if*
29 *requested by the department pursuant to a drug testing plan.*

30 *An individual's failure to submit to testing or failure to successfully*
31 *pass a drug test shall result in ineligibility for food assistance until a drug*

40 (14) *No TANF cash assistance shall be used to purchase alcohol,*
41 *cigarettes, tobacco products, lottery tickets, concert tickets, professional*
42 *or collegiate sporting event tickets or tickets for other entertainment*
43 *events intended for the general public or sexually oriented adult materials.*

1 No TANF cash assistance shall be used in any retail liquor store, casino,
2 gaming establishment, jewelry store, tattoo parlor, massage parlor, body
3 piercing parlor, spa, nail salon, lingerie shop, tobacco paraphernalia
4 store, vapor cigarette store, psychic or fortune telling business, bail bond
5 company, video arcade, movie theater, swimming pool, cruise ship, theme
6 park, dog or horse racing facility, parimutuel facility, or sexually oriented
7 business or any retail establishment which provides adult-oriented
8 entertainment in which performers disrobe or perform in an unclothed
9 state for entertainment, or in any business or retail establishment where
10 minors under age 18 are not permitted. TANF cash assistance transactions
11 for cash withdrawals from automated teller machines shall be limited to
12 ~~\$60, as adjusted by the consumer price index~~ **(\$25)**, per transaction and to
13 one transaction per day. No TANF cash assistance shall be used for
14 purchases at points of sale outside the state of Kansas.

15 (15) (A) The secretary for children and families shall place a
16 photograph of the recipient, if agreed to by such recipient of public
17 assistance, on any Kansas benefits card issued by the Kansas department
18 for children and families that the recipient uses in obtaining food, cash or
19 any other services. When a recipient of public assistance is a minor or
20 otherwise incapacitated individual, a parent or legal guardian of such
21 recipient may have a photograph of such parent or legal guardian placed
22 on the card.

23 (B) Any Kansas benefits card with a photograph of a recipient shall
24 be valid for voting purposes as a public assistance identification card in
25 accordance with the provisions of K.S.A. 25-2908, and amendments
26 thereto.

27 (C) As used in this paragraph and its subparagraphs, "Kansas
28 benefits card" means any card issued to provide food assistance, cash
29 assistance or child care assistance, including, but not limited to, the vision
30 card, EBT card and Kansas benefits card.

31 (16) The secretary for children and families shall adopt rules and
32 regulations:

33 (A) In determining eligibility for the child care subsidy program,
34 including an income of a cohabiting partner in a child care household;
35 and

36 (B) in determining and maintaining eligibility for non-TANF child
37 care, requiring that all included adults shall be employed a minimum of 20
38 hours per week or more as defined by the secretary or meet the following
39 specific qualifying exemptions:

40 (i) Adults who are not capable of meeting the requirement due to a
41 documented physical or mental condition;

42 (ii) adults who are former TANF recipients who need child care for
43 employment after their TANF case has closed and earned income is a

1 factor in the closure in the two months immediately following TANF

3 (iii) adult parents included in a case in which the only child receiving
4 benefits is the child of a minor parent who is working on completion of
5 high school or obtaining a GED; or

6 (iv) adults who are participants in a mandatory food assistance
7 education and training program.

8 The department for children and families shall provide child care for
9 the pursuit of any degree or certification if the occupation has at least an
10 average job outlook listed in the occupational outlook of the U.S.
11 department of labor, bureau of labor statistics. For occupations with less
12 than an average job outlook, educational plans shall require approval of
13 the secretary or secretary's designee. Child care may also be approved if
14 the student provides verification of a specific job offer that will be
15 available to such student upon completion of the program. Child care for
16 post-secondary education shall be allowed for a lifetime maximum of 24
17 months per adult. The 24 months may not have to be consecutive. Students
18 shall be engaged in paid employment for a minimum of 15 hours per week.
19 In a two-parent adult household, child care would not be allowed if both
20 parents are adults and attending a formal education or training program
21 at the same time. The household may choose which one of the parents is
22 participating as a post-secondary student. The other parent shall meet
23 another approvable criteria for child care subsidy.

24 (17) The secretary for children and families is prohibited from
25 requesting or implementing a waiver or program from the U.S. department
26 of agriculture for the time limited assistance provisions for able-bodied
27 adults aged 18 through 49 without dependents in a household under the
28 food assistance program. The time on food assistance for able-bodied
29 adults aged 18 through 49 without dependents in the household shall be
30 limited to three months in a 36-month period if such adults are not
31 meeting the requirements imposed by the U.S. department of agriculture
32 that they must work for at least 20 hours per week or participate in a
33 federally approved work program or its equivalent.

34 (18) Eligibility for the food assistance program shall be limited to
35 those individuals who are citizens or who meet qualified non-citizen status
36 as determined by U.S. department of agriculture. Non-citizen individuals
37 who are unable or unwilling to provide qualifying immigrant
38 documentation, as defined by the U.S. department of agriculture, residing
39 within a household shall not be included when determining the
40 household's size for the purposes of assigning a benefit level to the
41 household for food assistance or comparing the household's monthly
42 income with the income eligibility standards. The gross non-exempt
43 earned and unearned income and resources of disqualified individuals

1 *shall be counted in its entirety as available to the remaining household*

3 *(19) The secretary for children and families shall not enact the state*
4 *option from the U.S. department of agriculture for broad-based*
5 *categorical eligibility for households applying for food assistance*
6 *according to the provisions of 7 C.F.R. § 273.2(j)(2)(ii).*

7 *(20) No federal or state funds shall be used for television, radio or*
8 *billboard advertisements that are designed to promote food assistance*
9 *benefits and enrollment. No federal or state funding shall be used for any*
10 *agreements with foreign governments designed to promote food*
11 *assistance.*

12 *(21) (A) The secretary for children and families shall not apply gross*
13 *income standards for food assistance higher than the standards specified*
14 *in 7 U.S.C. § 2014(c) unless expressly required by federal law.*
15 *Categorical eligibility exempting households from such gross income*
16 *standards requirements shall not be granted for any non-cash, in-kind or*
17 *other benefit unless expressly required by federal law.*

18 *(B) The secretary for children and families shall not apply resource*
19 *limits standards for food assistance that are higher than the standards*
20 *specified in 7 U.S.C. § 2014(g)(1) unless expressly required by federal*
21 *law. Categorical eligibility exempting households from such resource*
22 *limits shall not be granted for any non-cash, in-kind or other benefit*
23 *unless expressly required by federal law.*

24 *(c) ~~Aid to families with dependent children~~ Temporary assistance for*
25 *needy families; assignment of support rights and limited power of*
26 *attorney. By applying for or receiving ~~aid to families with dependent~~*
27 *~~children~~ temporary assistance for needy families such applicant or*
28 *recipient shall be deemed to have assigned to the secretary on behalf of the*
29 *state any accrued, present or future rights to support from any other person*

23 designation will cause the full value of the property to be considered an

34 is to be secondary to all resources, including trusts, that may be available
35 to an applicant or recipient of medical assistance.

36 (B) If a trust has discretionary language, the trust shall be considered
37 to be an available resource to the extent, using the full extent of discretion,
38 the trustee may make any of the income or principal available to the
39 applicant or recipient of medical assistance. Any such discretionary trust
40 shall be considered an available resource unless: (i) At the time of creation
41 or amendment of the trust, the trust states a clear intent that the trust is
42 supplemental to public assistance; and (ii) the trust: (a) Is funded from
43 resources of a person who, at the time of such funding, owed no duty of

1 support to the applicant or recipient of medical assistance; or (b) is funded
2 not more than nominally from resources of a person while that person

9 a nonlicensed individual or provider and such contract, agreement or
10 accord involves health and welfare monitoring, pharmacy assistance, case

12 or other activities related to home health care, long term care, medical
13 assistance benefits, or other related issues, any moneys paid under such
14 contract, agreement or accord shall be considered to be an available
15 resource unless the following restrictions are met: (i) The contract,
16 agreement or accord must be in writing and executed prior to any services
17 being provided; (ii) the moneys paid are in direct relationship with the fair
18 market value of such services being provided by similarly situated and
