[Such] If the representative fails to respond to communications within a reasonable period of time, such an officer or employee, upon notice to the representative, and with 20 the consent of the immediate supervisor of such officer or employee, may notify the taxpayer directly that such officer or employee believes such representative is responsible for unreasonable delay or hindrance of a division of taxation examination or investigation of the taxpayer. 24
