SENATE BILL **4**

AN ACT relative to eligibility to vote and relative to availability of voter information.

AMENDED ANALYSIS

This bill:

I. Expands the definition of domicile for voting purposes and requires that a voter be a resident of the state for at least 30 days.

II. Modifies the voter registration form.

III. Allows otherwise confidential voter information to be made available to the legislature in an aggregated or statistical data format.

STATE OF NEW HAMPSHIRE

*In the Year of Our Lord Two Thousand Fifteen*

AN ACT relative to eligibility to vote and relative to availability of voter information.

*Be it Enacted by the Senate and House of Representatives in General Court convened:*

1 1 Voter; Domicile. Amend RSA 654:1, I to read as follows:

2 I.(a) Every inhabitant [~~of the state~~], having [~~a single~~] established domicile [~~for voting~~  
3 ~~purposes~~] ***in this state for no less than 30 consecutive days before any election where the***  
4 ***inhabitant offers to vote***, being a citizen of the United States, of the age provided for in Article 11  
5 of Part First of the Constitution of New Hampshire, shall have a right at any meeting or election, to  
6 vote in the town, ward, or unincorporated place in which he or she is domiciled.

7 (b)(1) An inhabitant's domicile for voting purposes [~~is that one place where a person,~~  
8 ~~more than any other place, has established a physical presence and manifests an intent to maintain~~  
9 ~~a single continuous presence for domestic, social, and civil purposes relevant to participating in~~  
10 ~~democratic self-government.~~] ***shall be the principal or primary home or place of abode of a***  
11 ***person. Principal or primary home or place of abode is that home or place in which his or***  
12 ***her habitation is fixed and to which a person, whenever he or she is temporarily absent,***  
13 ***has the intention of returning after a departure or absence therefrom, including when the***  
14 ***person is absent because of military service or temporarily absent as described in***  
15 ***RSA 654:2.***

16 (2) ***In determining what is a principal or primary place of abode of a***  
17 ***person, without limitation the following factors or evidence relating to such person may be***  
18 ***taken into account: civic and community participation, the place where a person spends***  
19 ***most nights of the year, the location from which a person would apply for a passport or***  
20 ***other federal identification, residence for income or other tax purposes, eligibility for a***  
21 ***resident hunting and fishing license, and a New Hampshire driver's license.***

22 (3) ***A qualified voter who has left his or her home and gone into another***  
23 ***state or town of this state for a temporary purpose only shall not be considered to have lost***  
24 ***his or her domicile as described in RSA 654:2.***

25 (4) ***A person shall not be considered to have gained a domicile in any town***  
26 ***or ward of this state into which he or she comes for temporary purposes only, without the***  
27 ***intention of making it his or her home but with the intention of leaving it when he or she***  
28 ***has accomplished the purpose that brought him or her there. Evidence that a person who,***  
29 ***prior to arriving in New Hampshire, was domiciled in another state and is temporarily***  
30 ***present in New Hampshire for any purpose including, but not limited to vacation, short-***  
31 ***term temporary work, volunteering for social or civic purposes, or volunteering or working***

1 *on political campaigns is not sufficient evidence that the person has established a*  
2 *domicile in New Hampshire.*

3 *(5) If a qualified voter moves to another state, with the intention of making*  
4 *it his or her permanent home, he or she shall be considered to have lost his or her domicile*  
5 *in this state.*

6 (c) A person has the right to change domicile at any time, however a mere intention to  
7 change domicile in the future does not, of itself, terminate an established domicile before the person  
8 actually moves.

9 2 New Paragraphs; Voter; Domicile. Amend RSA 654:1 by inserting after paragraph I-a the  
10 following new paragraphs:

11 I-b. Any person who establishes a voting domicile that otherwise meets the requirement of  
12 paragraph I, later than 30 days before any election where the inhabitant offers to vote shall vote at  
13 the polling place for the town or ward of his or her most recent previous domicile. Except that any  
14 person who transfers an existing New Hampshire voter registration and satisfies the requirements  
15 of this chapter for proving his or her new domicile may vote at the polling place for the town or  
16 ward of his or her new domicile.

17 I-c. Any person who met the requirements of this chapter to register to vote in New  
18 Hampshire who has established a voting domicile outside of New Hampshire within the 30  
19 consecutive days before an election and is not allowed to register and vote in that election in the  
20 state of his or her new domicile because he or she established that new domicile within 30  
21 consecutive days before that election may vote at the polling place for the New Hampshire town or  
22 ward where he or she was previously domiciled.

23 3 Voter Registration Form. Amend RSA 654:7, IV to read as follows:

24 IV.(a) [A] Standard registration application [~~form~~] **forms** shall be used throughout the  
25 state. The registration [~~form~~] **forms** shall be no larger than 8 1/2 inches by 11 inches.

26 (b) The secretary of state shall prescribe the form of the voter registration form to be  
27 used for voter registrations, **transfers, or updates** other than those at the polling place on the date  
28 of a state general election, which shall be in substantially the following form:

In declaring New Hampshire as my domicile, I realize that I am not qualified to vote in the state or federal elections in another state.

If I have any questions as to whether I am entitled to vote in this city/town, I am aware that a supervisor of the checklist is available to address my questions or concerns.

I acknowledge that I have read and understand the above qualifications for voting and do hereby swear, under the penalties for voting fraud set forth below, that I am qualified to vote in the above-stated city/town, and, if registering on election day, that I have not voted and will not vote at any other polling place this election.

In accordance with RSA 659:34, the penalty for knowingly or purposefully providing false information when registering to vote or voting is a class A misdemeanor with a maximum sentence of imprisonment not to exceed one year and a fine not to exceed \$2,000. Fraudulently registering to vote or voting is subject to a civil penalty not to exceed \$5,000.

(c) The secretary of state shall prescribe the form of the voter registration form to be used only for voter registrations, ***transfers, or updates*** at the polling place on the date of a state general election, which shall be in substantially the following form:

In accordance with RSA 659:34, the penalty for knowingly or purposefully providing false information when registering to vote or voting is a class A misdemeanor with a maximum sentence of imprisonment not to exceed one year and a fine not to exceed \$2,000. Fraudulently registering to vote or voting is subject to a civil penalty not to exceed \$5,000.

4 Right to Know Exemption. Amend RSA 654:31-a to read as follows:

654:31-a Right to Know Exemption. The information contained on the checklist of a town or city, specifically, the name, domicile address, mailing address, town or city, and party affiliation, if any, of registered voters, except as otherwise provided by statute, is public information subject to RSA 91-A. All other information on the voter registration form, absentee registration affidavit, qualified voter and domicile affidavits, affidavit of religious exemption, and application for absentee ballot shall be treated as confidential information and the records containing this information shall be exempt from the public disclosure provisions of RSA 91-A, except as provided by statutes other than RSA 91-A. ***However, otherwise confidential information on registration forms, absentee registration affidavits, qualified voter affidavits, challenged voter affidavits, domicile affidavits, affidavits of religious exemption, and applications for absentee ballot***

1 *shall be made available to the legislature in an aggregated or statistical data format that*  
2 *conceals the identities of individual voters. Said aggregated or statistical data may be*  
3 *presented in public legislative hearings.* Notwithstanding the foregoing, qualified voter and

4 domicile affidavits are public records subject to RSA 91-A for the sole purpose of challenging an  
5 individual registering to vote or voting, challenging ballots to be recounted, to the extent that such  
6 ballot challenges are specifically authorized by law, or determining the accuracy of any qualified  
7 voter or domicile affidavit. Election officials and law enforcement personnel in furtherance of their  
8 official duties may access and may disclose information from the voter registration form, qualified  
9 voter and domicile affidavits, affidavits of religious exemption, absentee registration affidavits, and  
10 applications for absentee ballots, if necessary to resolve a challenge to an individual registering to  
11 vote or voting, or if necessary to investigate or prosecute election law violations or any crime. Law  
12 enforcement access and use of such records for the investigation or prosecution of crimes unrelated  
13 to election law violations shall be limited to the records of the specific individuals who are the  
14 subject of the investigation or prosecution.

15       5 Effective Date. This act shall take effect upon its passage.
