MAKING AN APPROPRIATION TO THE STATE DEPARTMENT OF PUBLIC EDUCATION FOR A COMMUNITY EDUCATION PROGRAM FOR THE TAOS MUNICIPAL SCHOOLS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATIONS.--

A. Two hundred thousand dollars (\$200,000) is appropriated from the general fund to the state department of public education for expenditure in fiscal year 1996 to implement a broad-based community education program for the Taos municipal schools. Any unexpended or unencumbered balance remaining at the end of fiscal year 1996 shall revert to the general fund.

B. The community education program funded pursuant to Subsection A of this section shall include implementation
