AN ACT

CREATING THE LEGISLATIVE HEALTH CARE TASK FORCE: MAKING AN APPROPRIATION; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. HEALTH CARE TASK FORCE CREATED--TERMINATION. --There is created a joint interim legislative task force, which shall be known as the "health care task force". The task force shall function from the date of its appointment until the first day of December prior to the first session of the forty-fourth legislature.

MEMBERSHI P- - APPOI NTMENT- - VACANCI ES. - -Section 2.

The health care task force shall be composed of twelve voting legislative members and ten voting nonlegislative members. The speaker of the house of representatives shall appoint six members of the house of representatives, one of whom

shall be the chairman or vice chairman of the legislative health and human services committee, and the president pro tempore of the senate shall appoint six members of the senate, one of whom shall be the chairman or vice chairman of the legislative health and human services committee. The speaker of the house of representatives and the president pro tempore of the senate shall designate the chairman and vice chairman of the task force.

- B. Members of the health care task force shall be appointed from each house to give the two major political parties in each house the same proportional representation on the task force as prevails in each house; however, in no event shall either party have less than one member from each house on the task force. Vacancies on the task force shall be filled by appointment in the same manner as the original appointments.
- C. No action shall be taken by the health care task force if a majority of the total membership from either house on the health care task force rejects the action.
- D. The nonlegislative members of the health care task force who do not serve ex officio shall be appointed by the speaker of the house of representatives and the president protempore of the senate as follows:
- (1) two public members representing the business community, one representing small employers and one representing large employers;

2	expertise in the area of health care;					
3	(3) a health care reform advocate; and					
4	(4) two members of a Native American nation,					
5	tribe or pueblo of this state.					
6	E. The additional nonlegislative members shall be:					
7	(1) the secretary of human services or the					
8	secretary's designee;

10	desi gnee;					
11	(3) a representative of the New Mexico health					
12	policy commission; and					
13	(4) the superintendent of insurance or the					
14	superintendent's designee.					
15	F. The public members shall be paid per diem and					
16	mileage in accordance with the provisions of the Per Diem and					
17	Mileage Act.					
18	Section 3. DUTIESAfter the health care task force					
19	members are appointed, the task force shall hold one					
20	organizational meeting to develop a work plan and budget for the					
21	ensuing interim. The work plan and budget shall be submitted to					
22	the legislative council for approval. Upon approval of the work					
23	plan and budget by the legislative council, the task force shall					
24	review health care reform issues, including making efforts to:					
25	A. facilitate an ongoing partnership between the

a public member who is an attorney with

legislative and executive branches and bring together various groups working on health care reforms to:

- (1) improve the health status of New Mexicans;
- (2) enhance access to medical services with a commitment to protecting vulnerable populations;
- (3) strengthen the currently existing local health care infrastructure, both private and public, to assure appropriate access to needed services;
- (4) protect the quality of health care from erosion for cost savings; and
- (5) improve the efficiency of health care delivery;
- B. consider and investigate the supply and distribution of the state's health professional work force to determine what providers and infrastructure are necessary for health care delivery, including the development of priorities for geographic access of health care service in the state to revise the composition of health professionals to meet the health care service needs of the state;
- C. investigate legal, regulatory and policy issues affecting health care services in the state, including managed care in general and the medicaid managed care program in particular;
- D. oversee developments to the health information system, including the efforts of the health information

alliance, the initiation of confidential health information and patient privacy legislation and consumer report cards;

- E. investigate the role of the university of New Mexico health sciences center regarding its service mission as a vital education institution in the state and its role in filling the gaps of health care service where the private sector is unable to deliver service:
- F. create and sustain an ongoing dialogue with representatives from New Mexico Indian nations, tribes and pueblos to discuss health care issues related to Native American people, the role of the Indian health service as a provider of health care services and the integration of the medicaid managed care program with the Indian health service and Indian communities;
- G. provide legislative oversight on the implementation of health care reform measures, health care delivery and payment proposals and changes in federal and state law that impact health care reform programs that become law; and
- H. recommend legislation or changes if any are found to be necessary to the second session of the forty-third legislature and to the first session of the forty-fourth legislature.
- Section 4. SUBCOMMITTEES.--Subcommittees shall be created only by majority vote of all members appointed to the health care task force and with the prior approval of the legislative

council. A subcommittee shall be composed of at least one member from the senate and one member from the house of representatives, and at least one member of the minority party shall be a member of the subcommittee. All meetings and expenditures of a subcommittee shall be approved by the full task force in advance of such meeting or expenditure, and the approval shall be shown in the minutes of the task force.

Section 5. REPORT.--The health care task force shall make a report of its findings and recommendations for the consideration of the second session of the forty-third legislature and the first session of the forty-fourth legislature. The reports and suggested legislation shall be made available to the legislative council, the legislative finance committee, the legislative health and human services committee, the New Mexico health policy commission and the governor on or before November 30 preceding each session.

Section 6. STAFF.--The staff for the health care task force shall be provided by the legislative council service, and the staff of the New Mexico health policy commission shall assist the health care task force as requested. The legislative council service at the direction of the task force may hire additional staff as necessary and may contract with experts, including economists, actuaries and the bureau of business and economic research at the university of New Mexico, to assist the task force in carrying out its tasks.

Section 7. APPROPRIATION.--For the purpose of paying the salaries and expenses of the technical, professional, legal, clerical and stenographic assistants; for necessary equipment and supplies used in carrying out the provisions of this act; for travel expenses for staff and task force members; and for reimbursing the per diem and mileage expenses of the health care task force, there is appropriated to the legislative council service from the general fund the sum of one hundred thousand dollars (\$100,000) for expenditure in fiscal year 1998. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund. Payments from the appropriation shall be made upon vouchers signed by the director of the legislative council service or the director's authorized representative.

Section 8. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
