B. The first full term of the office of magistrate in the Luna magistrate district division 2 shall be filled by election at the general election in 1998, and that term of office shall begin on January 1, 1999.

Section 3. APPROPRIATION. --Fifty thousand dollars (\$50,000) is appropriated from the general fund to the administrative office of the courts for expenditure in fiscal year 1998 for salary, benefits, office space and supplies for one magistrate judge in the Luna magistrate district division 2. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.


