A bill for an act

1.1 relating to agriculture; making policy and technical changes to various agricultural
1.2 provisions including provisions related to aquaculture, pesticide control, food
1.3 handlers, eggs, milk, cheese, incentive programs, loan programs, soil, agriculture
1.4 basins, and other agriculture provisions; amending Minnesota Statutes 2016,
1.5 sections 17.117, subdivisions 1, 4, 11; 17.494; 17.4982, by adding subdivisions;
1.6 18B.34, subdivision 5; 25.33, subdivision 8; 28A.04, subdivision 1; 28A.08,
1.7 subdivision 3; 29.26; 34A.11, subdivision 7; 41A.15, subdivision 10, by adding a
1.8 subdivision; 41A.16, subdivisions 1, 2, 4; 41A.17, subdivisions 1, 2, 3; 41A.18,
1.9 subdivisions 1, 3; 41B.02, subdivision 10a; 41B.047, subdivisions 1, 3; 41B.049,

1.16 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.17 Section 1. Minnesota Statutes 2016, section 17.117, subdivision 1, is amended to read:

1.18 Subdivision 1. **Purpose.** The purpose of the agriculture best management practices loan
1.19 program is to provide low or no interest financing to farmers, agriculture supply businesses,
1.20 rural landowners, chapter 103E drainage authorities, and water-quality cooperatives for the
1.21 implementation of agriculture and other best management practices that reduce environmental
1.22 pollution.

1.23 **EFFECTIVE DATE.** This section is effective the day following final enactment.

1.24 Sec. 2. Minnesota Statutes 2016, section 17.117, subdivision 4, is amended to read:

1.25 Subd. 4. **Definitions.** (a) For the purposes of this section, the terms defined in this
1.26 subdivision have the meanings given them.

2.1 (b) "Agricultural and environmental revolving accounts" means accounts in the
2.2 agricultural fund, controlled by the commissioner, which hold funds available to the program.

2.3 (c) "Agriculture supply business" means a person, partnership, joint venture, corporation,
2.4 limited liability company, association, firm, public service company, or cooperative that
2.5 provides materials, equipment, or services to farmers or agriculture-related enterprises.

2.6 (d) "Allocation" means the funds awarded to an applicant for implementation of best
2.7 management practices through a competitive or noncompetitive application process.

2.8 (e) "Applicant" means a local unit of government eligible to participate in this program
2.9 that requests an allocation of funds as provided in subdivision 6b.

2.10 (f) "Best management practices" has the meaning given in sections 103F.711, subdivision
2.11 3, and 103H.151, subdivision 2. Best management practices also means other practices,
2.12 techniques, and measures that have been demonstrated to the satisfaction of the
2.13 commissioner: (1) to prevent or reduce adverse environmental impacts by using the most
2.14 effective and practicable means of achieving environmental goals; or (2) to achieve drinking
2.15 water quality standards under chapter 103H or under Code of Federal Regulations, title 40,
2.16 parts 141 and 143, as amended.

2.17 (g) "Borrower" means a farmer, an agriculture supply business, ~~or~~ a rural landowner, or
2.18 a chapter 103E drainage authority applying for a low-interest loan.

2.19 (h) "Commissioner" means the commissioner of agriculture, including when the
2.20 commissioner is acting in the capacity of chair of the Rural Finance Authority, or the designee
2.21 of the commissioner.

2.22 (i) "Committed project" means an eligible project scheduled to be implemented at a
2.23 future date:

2.24 (1) that has been approved and certified by the local government unit; and

2.25 (2) for which a local lender has obligated itself to offer a loan.

2.26 (j) "Comprehensive water management plan" means a state-approved and locally adopted
2.27 plan authorized under section 103B.231, 103B.255, 103B.311, 103C.331, 103D.401, or
2.28 103D.405.

2.29 (k) "Cost incurred" means expenses for implementation of a project accrued because
2.30 the borrower has agreed to purchase equipment or is obligated to pay for services or materials
2.31 already provided as a result of implementing an approved eligible project.

3.1 (l) "Farmer" means a person, partnership, joint venture, corporation, limited liability
3.2 company, association, firm, public service company, or cooperative that regularly participates
3.3 in physical labor or operations management of farming and files a Schedule F as part of
3.4 filing United States Internal Revenue Service Form 1040 or indicates farming as the primary
3.5 business activity under Schedule C, K, or S, or any other applicable report to the United
3.6 States Internal Revenue Service.

3.7 (m) "Lender agreement" means an agreement entered into between the commissioner
3.8 and a local lender which contains terms and conditions of participation in the program.

3.9 (n) "Local government unit" means a county, soil and water conservation district, or an
3.10 organization formed for the joint exercise of powers under section 471.59 with the authority
3.11 to participate in the program.

3.12 (o) "Local lender" means a local government unit as defined in paragraph (n), a state or
3.13 federally chartered bank, a savings association, a state or federal credit union, Agribank
3.14 and its affiliated organizations, or a nonprofit economic development organization or other
3.15 financial lending institution approved by the commissioner.

3.16 (p) "Local revolving loan account" means the account held by a local government unit
3.17 and a local lender into which principal repayments from borrowers are deposited and new
3.18 loans are issued in accordance with the requirements of the program and lender agreements.

3.19 (q) "Nonpoint source" has the meaning given in section 103F.711, subdivision 6.

3.20 (r) "Program" means the agriculture best management practices loan program in this
3.21 section.

3.22 (s) "Project" means one or more components or activities located within Minnesota that
3.23 are required by the local government unit to be implemented for satisfactory completion of
3.24 an eligible best management practice.

3.25 (t) "Rural landowner" means the owner of record of Minnesota real estate located in an
3.26 area determined by the local government unit to be rural after consideration of local land
3.27 use patterns, zoning regulations, jurisdictional boundaries, local community definitions,
3.28 historical uses, and other pertinent local factors.

3.29 (u) "Water-quality cooperative" has the meaning given in section 115.58, paragraph (d),
3.30 except as expressly limited in this section.

3.31 **EFFECTIVE DATE.** This section is effective the day following final enactment.

4.1 Sec. 3. Minnesota Statutes 2016, section 17.117, subdivision 11, is amended to read:

4.2 Subd. 11. **Loans issued to borrower.** (a) Local lenders may issue loans only for projects
4.3 that are approved and certified by the local government unit as meeting priority needs
4.4 identified in a comprehensive water management plan or other local planning documents,
4.5 are in compliance with accepted practices, standards, specifications, or criteria, and are
4.6 eligible for financing under Environmental Protection Agency or other applicable guidelines.

4.7 (b) The local lender may use any additional criteria considered necessary to determine
4.8 the eligibility of borrowers for loans.

4.9 (c) Local lenders shall set the terms and conditions of loans to borrowers, except that:

4.10 (1) no loan to a borrower may exceed \$200,000;

4.11 (2) no loan for a project may exceed \$200,000; and

4.12 (3) no borrower shall, at any time, have multiple loans from this program with a total
4.13 outstanding loan balance of more than \$200,000.

4.14 Notwithstanding the limits in clauses (1) to (3), a chapter 103E drainage authority may
4.15 request a loan to finance projects implemented on behalf of multiple landowners and the
4.16 loan must not exceed an amount equal to the number of landowners represented in the
4.17 drainage system multiplied by the limit in clause (1).

4.18 (d) The maximum term length for projects in this paragraph is ten years.

4.19 (e) Fees charged at the time of closing must:

4.20 (1) be in compliance with normal and customary practices of the local lender;

4.21 (2) be in accordance with published fee schedules issued by the local lender;

4.22 (3) not be based on participation program; and

4.23 (4) be consistent with fees charged other similar types of loans offered by the local
4.24 lender.

4.25 (f) The interest rate assessed to an outstanding loan balance by the local lender must not
4.26 exceed three percent per year.

4.27 **EFFECTIVE DATE.** This section is effective the day following final enactment.

4.28 Sec. 4. Minnesota Statutes 2016, section 17.494, is amended to read:

4.29 **17.494 AQUACULTURE PERMITS; RULES.**

5.1 (a) The commissioner shall act as permit or license coordinator for aquatic farmers and
5.2 shall assist aquatic farmers to obtain licenses or permits.

5.3 ~~By July 1, 1992,~~ (b) A state agency issuing multiple permits or licenses for aquaculture
5.4 shall consolidate the permits or licenses required for every aquatic farm location. The
5.5 Department of Natural Resources transportation permits are exempt from this requirement.
5.6 State agencies shall adopt rules or issue commissioner's orders that establish permit and
5.7 license requirements, approval timelines, and compliance standards. Saltwater aquatic farms,
5.8 as defined in section 17.4982, and processing facilities for saltwater aquatic life, as defined
5.9 in section 17.4982, must be classified as agricultural operations for purposes of any
5.10 construction, discharge, or other permit issued by the Pollution Control Agency.

5.11 Nothing in this section modifies any state agency's regulatory authority over aquaculture
5.12 production.

5.13 Sec. 5. Minnesota Statutes 2016, section 17.4982, is amended by adding a subdivision to
5.14 read:

5.15 Subd. 20a. **Saltwater aquaculture.** "Saltwater aquaculture" means the commercial
5.16 propagation and rearing of saltwater aquatic life including, but not limited to, crustaceans,
5.17 primarily for consumption as human food.

5.18 Sec. 6. Minnesota Statutes 2016, section 17.4982, is amended by adding a subdivision to
5.19 read:

5.20 Subd. 20b. **Saltwater aquatic farm.** "Saltwater aquatic farm" means a facility used for
5.21 saltwater aquaculture including but not limited to artificial ponds, vats, tanks, raceways,
5.22 and other facilities that an aquatic farmer owns or has exclusive control of for the sole
5.23 purpose of producing saltwater aquatic life.

5.24 Sec. 7. Minnesota Statutes 2016, section 17.4982, is amended by adding a subdivision to
5.25 read:

5.26 Subd. 20c. **Saltwater aquatic life.** "Saltwater aquatic life" means aquatic species that
5.27 are saltwater obligates or perform optimally when raised in salinities closer to that of natural
5.28 seawater and need saltwater to survive.

6.1 Sec. 8. [17.499] TRANSPORTATION OR IMPORTATION OF SALTWATER
6.2 AQUATIC LIFE; QUARANTINE REQUIREMENT.

6.3 Subdivision 1. Purpose. The legislature finds that it is in the public interest to increase
6.4 private saltwater aquaculture production and processing in this state under the coordination
6.5 of the commissioner of agriculture. Additional private production will reduce dependence
6.6 on foreign suppliers and benefit the rural economy by creating new jobs and economic
6.7 activity.

6.8 Subd. 2. Transportation permit. (a) Notwithstanding the requirements in section
6.9 17.4985, saltwater aquatic life transportation and importation requirements are governed
6.10 by this section. A transportation permit is required prior to any importation or intrastate
6.11 transportation of saltwater aquatic life not exempted under subdivision 3. A transportation
6.12 permit may be used for multiple shipments within the 30-day term of the permit if the source
6.13 and the destination remain the same. Transportation permits must be obtained from the
6.14 commissioner prior to shipment of saltwater aquatic life.

6.15 (b) An application for a transportation permit must be made in the form required by the
6.16 commissioner. The commissioner may reject an incomplete application.

6.17 (c) An application for a transportation permit must be accompanied by satisfactory
6.18 evidence, as determined by the commissioner, that the shipment is free of any nonindigenous
6.19 species of animal other than the saltwater aquatic species and either:

6.20 (1) the facility from which the saltwater aquatic life originated has provided
6.21 documentation of 36 or more consecutive months of negative testing by an approved
6.22 laboratory as free of any disease listed by OIE - the World Organisation for Animal Health
6.23 for that species following the testing guidelines outlined in the OIE Aquatic Animal Health
6.24 Code for crustaceans or the AFS Fish Health Blue Book for other species, as appropriate;
6.25 or

6.26 (2) the saltwater aquatic life to be imported or transported includes documentation of
6.27 negative testing for that specific lot by an approved laboratory as free of any disease listed
6.28 by OIE - the World Organisation for Animal Health for crustaceans or in the AFS Fish
6.29 Health Blue Book for other species, as appropriate.

6.30 If a shipment authorized by the commissioner under clause (1) includes saltwater aquatic
6.31 life that originated in a foreign country, the shipment must be quarantined at the receiving
6.32 facility according to a quarantine plan approved by the commissioner. A shipment authorized
6.33 by the commissioner under clause (2) must be quarantined at the receiving facility according
6.34 to a quarantine plan approved by the commissioner.

7.1 (d) For purposes of this subdivision, "approved laboratory" means a laboratory approved
7.2 by the commissioner or the United States Department of Agriculture, Animal and Plant
7.3 Health Inspection Services.

7.4 (e) No later than 14 calendar days after a completed transportation permit application
7.5 is received, the commissioner must approve or deny the transportation permit application.

7.6 (f) A copy of the transportation permit must accompany a shipment of saltwater aquatic
7.7 life while in transit and must be available for inspection by the commissioner.

7.8 (g) A vehicle used by a licensee for transporting aquatic life must be identified with the
7.9 license number and the licensee's name and town of residence as it appears on the license.
7.10 A vehicle used by a licensee must have identification displayed so that it is readily visible
7.11 from either side of the vehicle in letters and numbers not less than 2-1/2 inches high and
7.12 three-eighths inch wide. Identification may be permanently affixed to vehicles or displayed
7.13 on removable plates or placards placed on opposite doors of the vehicle or on the tanks
7.14 carried on the vehicle.

7.15 (h) An application to license a vehicle for brood stock or larvae transport or for use as
7.16 a saltwater aquatic life vendor that is received by the commissioner is a temporary license
7.17 until approved or denied by the commissioner.

7.18 Subd. 3. Exemptions. (a) A transportation permit is not required to transport or import
7.19 saltwater aquatic life:

7.20 (1) previously processed for use as food or other purposes unrelated to propagation;

7.21 (2) transported directly to an outlet for processing as food or for other food purposes if
7.22 accompanied by shipping documents;

7.23 (3) that is being exported if accompanied by shipping documents;

7.24 (4) that is being transported through the state if accompanied by shipping documents;

7.25 or

7.26 (5) transported intrastate within or between facilities licensed for saltwater aquaculture
7.27 by the commissioner if accompanied by shipping documents.

7.28 (b) Shipping documents required under paragraph (a) must include the place of origin,
7.29 owner or consignee, destination, number, species, and satisfactory evidence, as determined
7.30 by the commissioner, of the disease-free certification required under subdivision 2, paragraph
7.31 (c), clauses (1) and (2).

8.1 Sec. 9. Minnesota Statutes 2016, section 18B.34, subdivision 5, is amended to read:

8.2 Subd. 5. **Fees.** (a) A person initially applying for or renewing a noncommercial applicator
8.3 license must pay a nonrefundable application fee of \$50, except an applicant who ~~is~~ uses
8.4 pesticides in the course of performing official duties as: (1) a government employee; (2) a
8.5 contractor providing rest area custodial services for the commissioner of transportation; or
8.6 (3) a Conservation Corps Minnesota employee who uses pesticides in the course of
8.7 performing official duties must pay a nonrefundable application fee of \$10.

8.8 (b) A license renewal application received after March 1 in the year for which the license
8.9 is to be issued is subject to a penalty fee of 50 percent of the application fee. The penalty
8.10 fee must be paid before the renewal license may be issued.

8.11 (c) An application for a duplicate noncommercial applicator license must be accompanied
8.12 by a nonrefundable application fee of \$10.

8.13 Sec. 10. Minnesota Statutes 2016, section 25.33, subdivision 8, is amended to read:

8.14 Subd. 8. **Drug.** "Drug" means (1) any article intended for use in the diagnosis, cure,
8.15 mitigation, treatment, or prevention of disease in animals other than humans; and (2) articles
8.16 other than feed intended to affect the structure or any function of the animal body.

8.17 Sec. 11. Minnesota Statutes 2016, section 28A.04, subdivision 1, is amended to read:

8.18 Subdivision 1. **Application; date of issuance.** (a) No person shall engage in the business
8.19 of manufacturing, processing, selling, handling, or storing food without having first obtained
8.20 from the commissioner a license for doing such business. Applications for such license shall
8.21 be made to the commissioner in such manner and time as required and upon such forms as
8.22 provided by the commissioner and shall contain the name and address of the applicant,
8.23 address or description of each place of business, and the nature of the business to be
8.24 conducted at each place, and such other pertinent information as the commissioner may
8.25 require.

8.26 (b) A retail or wholesale food handler license shall be issued for the period July 1 to
8.27 June 30 following and shall be renewed thereafter by the licensee on or before July 1 each
8.28 year, except that:

9.10 for the period January 1 to December 31 following and shall be renewed thereafter by the
9.11 licensee on or before January 1 of each year, except that a license for a wholesale food
9.12 processor or manufacturer operating only at the state fair shall be issued for the period July
9.13 1 to June 30 following and shall be renewed thereafter by the licensee on or before July 1
9.14 of each year. A penalty for a late renewal shall be assessed in accordance with section

9.22 All persons required to have a license under section 28A.04 shall be classified into one

9.24 (a) Retail food handlers are persons who sell or process and sell food directly to the
9.25 ultimate consumer or who custom process meat or poultry. The term includes a person who
9.26 sells food directly to the ultimate consumer through the use of vending machines, and a
9.27 person who sells food for consumption on site or off site if the sale is conducted on the
9.28 premises that are part of a grocery or convenience store operation.

9.29 (b) Wholesale food handlers are persons who sell to others for resale. A person who
9.30 handles food in job lots (jobbers) is included in this classification.

9.31 (c) Wholesale food processors or manufacturers are persons who process or manufacture
9.32 raw materials and other food ingredients into food items, or who reprocess food items, or
9.33 who package food for sale to others for resale, or who commercially slaughter animals or

10.1 poultry. Included herein are persons who can, extract, ferment, distill, pickle, bake, freeze,
 10.2 dry, smoke, grind, mix, stuff, pack, bottle, recondition, or otherwise treat or preserve food
 10.3 for sale to others for resale, cold storage warehouse operators as defined in section 28.01,
 10.4 subdivision 3, salvage food processors as defined in section 31.495, subdivision 1, and dairy
 10.5 plants as defined in section 32D.01, subdivision 6.

10.6 (d) Custom exempt food handlers are persons who only conduct custom exempt
 10.7 processing as defined in section 31A.02, subdivision 5. A retail or wholesale transaction
 10.8 may not take place in a facility operated by a person with a custom exempt food handler
 10.9 license.

10.10 ~~(d)~~ (e) A food broker is a person who buys and sells food and who negotiates between
 10.11 a buyer and a seller of food, but who at no time has custody of the food being bought and
 10.12 sold.
