<u>The People of the State of New York, represented in Senate and Assembly, do enact as follows:</u>

p. A space for pre-registering applicants to respond to the following question: "Are you at least 16 years of age and understand that you must be 18 years of age on or before election day to vote, and that until you will be eighteen years of age at the time of such election your registration will be marked 'pending' and you will be unable to cast a ballot in any election?". 10 in any election?"

§ 5-507. Voter pre-registration and education on voter pre-registration. 1. Pre-registration. A person who is at least sixteen years of age and who is otherwise qualified to register to vote may pre-register to vote, and shall be automatically registered upon reaching the age of eligibility as provided by this chapter.

2. Encouragement of student voter registration and pre-registration. Local boards of education are required to adopt policies to promote student voter registration and pre-registration. These policies may include collaboration with county boards of elections to conduct voter registration and pre-registration in high schools. Completion and submission of voter registration or pre-registration forms shall not be a course requirement or graded assignment for students.

§ 4. This act shall take effect on the first of January next succeeding the date on which it shall have become a law. Effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act on its effective date are authorized to be made and completed on or before such effective date.
