2 **Public Utilities – Investor-Owned Utilities – Prevailing Wage**

3 FOR the purpose of requiring certain investor-owned gas, electric, or combination gas and
4 electric companies to require certain contractors and subcontractors to pay their
5 employees not less than the prevailing wage rate for certain projects; and generally
6 relating to investor-owned utilities and the prevailing wage.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

18 That the Laws of Maryland read as follows:

19 **Article – Public Utilities**

2 **(A) THIS SECTION APPLIES TO A PROJECT BY AN INVESTOR-OWNED GAS**
3 **COMPANY, ELECTRIC COMPANY, OR COMBINATION GAS AND ELECTRIC COMPANY**
4 **INVOLVING THE CONSTRUCTION, RECONSTRUCTION, INSTALLATION, DEMOLITION,**
5 **RESTORATION, OR ALTERATION OF ANY UNDERGROUND GAS OR ELECTRIC**
6 **INFRASTRUCTURE OF THE COMPANY, AND ANY RELATED TRAFFIC CONTROL**
7 **ACTIVITIES.**

8 **(B) AN INVESTOR-OWNED GAS COMPANY, ELECTRIC COMPANY, OR**
9 **COMBINATION GAS AND ELECTRIC COMPANY SHALL REQUIRE A CONTRACTOR OR**
10 **SUBCONTRACTOR ON A PROJECT DESCRIBED IN SUBSECTION (A) OF THIS SECTION**
11 **TO PAY ITS EMPLOYEES NOT LESS THAN THE PREVAILING WAGE RATE DETERMINED**
12 **BY THE COMMISSIONER OF LABOR AND INDUSTRY UNDER TITLE 17, SUBTITLE 2 OF**
13 **THE STATE FINANCE AND PROCUREMENT ARTICLE.**

16 (h) “Prevailing wage rate” means the hourly rate of wages paid in the locality as
17 determined by the Commissioner under § 17-208 of this subtitle.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
19 October 1, 2021.
