- 1.9 Section 1. **[2.155] FIFTEENTH DISTRICT.**
- 1.10 Subdivision 1. **Senate district.** Notwithstanding the order of the Minnesota Special
- 1.11 Redistricting Panel in Wattson v. Simon, Nos. A21-0243, A21-0546 (February 15, 2022),
- 1.12 Senate District 15 consists of the district as described in that order, with the modification
- 1.13 contained in file L15A-1, on file with the Geographic Information Systems Office of the

3.7 consists of the district as described in that order, with the modification contained in file
3.8 C07-1, on file with the Geographic Information Systems Office of the Legislative
3.9 Coordinating Commission and published on its website on May 4, 2022.

3.10 **Sec. 6. REPEALER.**

3.11 Minnesota Statutes 2020, sections 2.395; and 2.495, are repealed.

3.12 **Sec. 7. EFFECTIVE DATE; ESTABLISHMENT OF NEW PRECINCTS.**

3.13 This act is effective for the state primary and state general elections conducted in 2022
3.14 for terms of office beginning on the first Monday in January of 2023, and for all elections
3.15 held thereafter. Notwithstanding any law to the contrary, if a boundary adjustment contained
3.16 in this act requires a county, city, or town to reestablish a precinct boundary to conform to
3.17 the adjustment, the affected county, city, or town must reestablish the necessary precincts
3.18 as soon as practicable, but in no case later than June 17, 2022.

2.395 THIRTY-NINTH DISTRICT.

Subd. 2. **House of representatives districts.** Notwithstanding the order of the Minnesota Special Redistricting Panel in *Hippert v. Ritchie*, No. A11-152 (February 21, 2012), Senate District 39, as described in that order, is divided into two house of representatives districts as follows:

(a) House of Representatives District 39A consists of the district as described in that order, with the modification contained in file L39A-1, on file with the Geographic Information Systems Office of the Legislative Coordinating Commission and published on its website on March 9, 2012.

(b) House of Representatives District 39B consists of that district as described in that order, with the modification contained in file L39B-1, on file with the Geographic Information Systems Office of the Legislative Coordinating Commission and published on its website on March 9, 2012.

2.495 FORTY-NINTH DISTRICT.

(a) House of Representatives District 49A consists of the district as described in that order, with the modification contained in file L49A-2, on file with the Geographic Information Systems Office of the Legislative Coordinating Commission and published on its website on March 28, 2012.

(b) House of Representatives District 49B consists of the district as described in that order, with the modification contained in file L49B-2, on file with the Geographic Information Systems Office of the Legislative Coordinating Commission and published on its website on March 28, 2012.
