### 1995 VETO MESSAGES OF SENATE BILLS

### **S 946** VIETNAM CONFLICT DATES FOR TAXES

April 7, 1995

#### SENATE EXECUTIVE MESSAGE NO. 143

I have this day VETOED and am returning SENATE BILL 946, enacted by the Forty-Second Legislature, State of New Mexico, First Session, 1995.

This legislation would redefine the dates of the Vietnam Conflict for the purpose of qualifying for the veterans tax exemption. It is vetoed because the dates of the Vietnam Conflict are a matter of history and should not be misconstrued for any reason.

#### **S 950** LOW-INCOME HOUSING TRUST

April 7, 1995

#### SENATE EXECUTIVE MESSAGE NO. 128

I have this day VETOED and am returning SENATE BILL 950, as amended, with emergency clause, enacted by the Forty-Second Legislature, State of New Mexico, First Session, 1995.

This legislation would enact the Land Title Industry Low-Income Housing Trust Act and amend existing statutes to require title companies to deposit escrow monies into a special account. The interest generated was to be transferred to the state for use in developing housing for low income families and individuals. While the need for affordable housing cannot be denied, this bill is vetoed because it could potentially conflict with FDIC rules and regulations regarding interest on demand accounts and presents problems with respect to an unconstitutional taking by the state of private funds in violation of the due process clause.

## **S 986** EXPAND LOCAL HOSPITAL GROSS RECEIPTS

April 6, 1995

#### SENATE EXECUTIVE MESSAGE NO. 111

I have this day VETOED and am returning SENATE BILL 986, as amended, enacted by the Forty-Second Legislature, State of New Mexico, First Session, 1995.

#### 1995 VETO MESSAGES OF SENATE BILLS

This legislation would extend to three more counties the authority to increase local option gross receipts taxes for construction or operation of hospitals, with the additional ability to do so free of the requirement that half the necessary funds be raised through property taxes. It is vetoed because existing statute containing the property tax requirement is sufficient, and granting this additional authority could be viewed as a tax increase.

## S 991 NMFA PUBLIC EMPLOYER FOR PERA

April 5, 1995

#### SENATE EXECUTIVE MESSAGE NO. 85

I have this day VETOED and am returning SENATE BILL 991, enacted by the Forty-Second Legislature, State of New Mexico, First Session, 1995.

This legislation would make the employees of the New Mexico Finance Authority eligible for benefits under the Public Employees Retirement Act. This legislation is vetoed because the New Mexico Finance Authority is not a state agency, and its employees should not be covered by the state pension plan.

# **S 993** WORKERS' COMPENSATION BUILDING, NMFARB

April 5, 1995

### SENATE EXECUTIVE MESSAGE NO. 86.

I have this day VETOED and am returning SENATE BILL 993, with emergency clause, enacted by the Forty-Second Legislature, State of New Mexico, First Session, 1995.

The legislation authorizes the New Mexico Finance Authority to issue bonds to purchase and renovate a building for the Workers' Compensation Administration. It is vetoed because an adequate needs assessment and review process has not been conducted with regard to this proposal.
