VETO MESSAGE - No. 200

TO THE SENATE:

I am returning herewith, without my approval, the following bills:

Senate Bill Number 3951, entitled:

"AN ACT to amend the state finance law, in relation to establishing the civic education fund"

Senate Bill Number 4699, entitled:

"AN ACT in relation to requiring the commissioner of health to conduct a study relating to the number of emergency room beds"

Senate Bill Number 5202-A, entitled:

"AN ACT directing a study on the impact of increased minimum wage on eligibility for income-based services, programs and subsidies"

Senate Bill Number 5690, entitled:

"AN ACT to amend the New York state urban development corporation act, in relation to evaluation and assistance to increase access to child care"

Senate Bill Number 5716, entitled:

"AN ACT to amend the urban development corporation act, in relation to the beginning farmers NY fund"

Senate Bill Number 5855, entitled:

"AN ACT to direct the department of environmental conservation, with the assistance of the department of transportation, to conduct a study on the environmental and human health impacts of John F. Kennedy international airport and LaGuardia airport"

Senate Bill Number 6553, entitled:

"AN ACT establishing the New York task force on agricultural investment; and providing for the repeal of such provisions upon the expiration thereof"

TO THE ASSEMBLY:

I am returning herewith, without my approval, the following bills:

Assembly Bill Number 580, entitled:

"AN ACT to amend the social services law, in relation to implementing a cost estimation model for child care"

Assembly Bill Number 7574, entitled:

"AN ACT to amend the tax law, in relation to exempting certain car-sharing organizations from the special supplemental tax on passenger car rentals outside of the metropolitan commuter transportation district"

NOT APPROVED

Each of these bills would require significant state funding outside the budget process. These bills require numerous studies, disbursement of grants with no funding identified, costly tax incentives, and creation of new state offices and task forces.

The Legislature has failed, in every instance, to identify funds to implement these bills. Programs such as these, that have significant fiscal implications, must be discussed in the context of the budget process. It is irresponsible to have an agreement on a fiscal plan in April, only to then pass these measures and provide no source of funding, leaving taxpayers on the hook and shortchanging existing programs.

While each of these proposals have merit and are laudable in their own right, these decisions are appropriately made in the budget when global budget discussions and negotiations occur. For these insurmountable fiscal reasons, I am vetoing these bills, although I welcome the opportunity to discuss these studies, grant funds, tax incentives, and state offices and task forces in the context of the budget.

These bills are disapproved.
